The Court notes several issues in this case. The Catos believe their matter can be resolved, they only wish to pursue the two wells, not the Flag Hollow Lake stock pond. They report that they have someone helping them with filings and obtaining assignments and inquire if they are eligible to proceed with the de minimis process. It is likely however it will depend on the Statements of Claimant.

Ms. Newsome addresses the Court regarding their progress with Mr. Peterson. They have reviewed some documents but have not had sufficient time to view all of them. She will review the other two cases that the Court believes Mr. Peterson to be apart of, CV6417-33-6894 and CV6417-33-6896.

The Court will provide a 60-day deadline for the two landowners to get their documents filed and will set another Status Conference after to discuss how to proceed.
