Landowner, Virginia E. As a result, Ms. Pierre was ordered to attend a status conference on April 24, 2024, to update the Court on her progress resolving objections to the potential water right. Ms. Pierre failed to attend the conference or provide any updates to the Court.

THEREFORE, IT IS ORDERED that that by **June 28, 2024,** Ms. Pierre shall file with the Court a written statement explaining her failure to appear on March 6, 2024, and provide to the Court evidence of filing with ADWR updated SOCs and an estimate of the time needed to file the appropriate basis of right of application. Failure to provide the documentation as ordered by the Court shall result in the dismissal of Ms. Pierre's potential claim.
