The Court notes that this is the second resetting of this Status Conference and no landowners have appeared. There are two Statements of Claimants ("SOCs") that go across a number of Watershed File Reports ("WFR"), the Court will just dismiss this WFR not the SOCs.

Ms. Wilkinson notes that the SOCs in this case are 39-86830 and 39-86831. She recalls that these SOCs were already dismissed in CV6417-33-6898 and inquires if the SOCs have been reinstated. The Court has not reinstated them at this time but if a case involving the SOCs moves forward the Court will appropriately reinstate them.

Due to the landowner's failure to appear,

**IT IS ORDERED** dismissing the Watershed File Report No. 33-56-ACAD-004.
