IT IS FURTHER ORDERED the Hopi Tribe shall supplement its Initial Rule 26.1 Disclosure Statement and file expert reports for past and present water uses on **March 6**, 2017.

IT IS FURTHER ORDERED the Hopi Tribe shall supplement its Initial Rule 26.1 Disclosure Statement and file expert reports for future water uses on **June 16, 2017.**

IT IS FURTHER ORDERED that the statements due February 8, 2017, identifying deficiencies in water attributes in expert reports will be limited to expert reports filed by the United States for past and present water uses.
