On November 1, 2017, the Hopi Tribe filed a Request for Pre-Trial and Trial Guidelines (the Hopi Request). A comprehensive schedule for the preparation and distribution of the joint pretrial statement was included in the Hopi Request. In addition, requests were made with respect to the exhibits and a notification procedure regarding the use of testimony taken in this proceeding that will be used in the proceeding for future water uses. These requests need to be considered

1 as well as additional pretrial issues the parties believe should be addressed. The parties shall file
2 their responses to the Hopi's Request as well as a description of other procedural pretrial issues
3 that should be considered at a pretrial conference by March 16, 2018.

4 A proposed schedule for key dates is as follows:

5 June 22, 2018	Motions in Limine due.
6 August 22, 2018	Joint Pretrial Statement due.
7 September 4, 2018	Readiness Conference

10 The trial will begin on Tuesday, **September 11, 2018**, rather than on September 10, 2018.
11 At the pretrial conference, the parties will be expected to provide their best estimates regarding
12 the anticipated length of trial so that trial dates can be set.
