CONTESTED CASE NAME: *In re Arizona Chapter of the Nature Conservancy – Aravaipa Creek De Minimis.*

HSR INVOLVED: San Pedro River Watershed Hydrographic Survey Report.

DESCRIPTIVE SUMMARY: Vacates requirement that objectors file responses to amended statements of claimant in this case for *de minimis* water uses and directs the Arizona Department of Water Resources to review the legal descriptions of the places of use and points of diversion listed in the proposed abstracts.

NUMBER OF PAGES: 34.

DATE OF FILING: March 2, 2018.

On February 15, 2018, The Arizona Chapter of the Nature Conservancy filed a consolidated abstract of statements of claimant that included entries for 25 claims for *de*

1 *minimis* water uses for stockponds and stock and wildlife watering analyzed in four watershed
 2 file reports: 115-05-30, 115-05-41, 115-05-44, and 115-05-49. The Arizona Chapter of the
 3 Nature Conservancy did not include an abstract for the *de minimis* water uses identified in
 4 watershed file report 115-04-10. At the status conference scheduled for April 4, 2018, The
 5 Arizona Chapter of the Nature Conservancy shall be prepared to state whether it intends to
 6 withdraw Statement of Claimant 39-5499 or whether it desires an in-stream stock watering
 7 water right as described by the potential water right 115-04-10-SW001.

10 The abstracts for *de minimis* water uses prepared by The Arizona Nature Conservancy
 11 conform to the water right characteristics listed by the Arizona Department of Water Resources

 25 The expedited adjudication process to adjudicate *de minimis* claims set forth in the
 26 Memorandum Decision, Findings of Fact, and Conclusions of Law for Group 1 Cases
 27 involving Stockwatering, Stockponds, and Domestic Uses, dated November 14, 1994,
 28

1 amended February 23, 1995, approved and modified September 27, 2002 (“Decision”)
2 requires the preparation of proposed water right abstracts that include the following
3 information: the proposed water right number, the owner of the water right, the landowner, the
4 statement of claimant number, the name of the claimant, the lessee or permittee, the basis of
5 the right, the beneficial use, the priority date, the quantity of water, the place of use, point of
6 diversion, source of water and name of facility, where available. The Decision set the
7 quantity of water adjudicated for stockponds as the “uniform volume of ‘not to exceed (<) 4
8 ac. ft. with continuous fill’ for all stockponds in the San Pedro River watershed having a
9 capacity of less than or equal to 4 ac. ft. or less.” Decision, p. 34. None of the claims for
10 stockponds at issue assert rights to water in excess of four acre feet annually. Attached as
11 Appendix A to this Order are draft abstracts for 25 proposed water rights.
12

13 **IT IS ORDERED** that the Arizona Department of Water Resources shall review the
14 legal descriptions for places of use and points of diversion in the draft abstracts and file a
15 report no later than April 13, 2017, setting forth any suggested corrections to the proposed
16 abstracts.
17

18 After ADWR has completed its review, the final proposed abstracts will be distributed
19 so that the litigants “have an opportunity to suggest the correction of mistakes in the proposed
20 abstracts.” Decision, p. 47. At this stage, the proceeding is not a forum in which to relitigate
21 the water characteristics or procedures set by the Decision, which was the subject of years of
22 briefing and has now been affirmed for more than 14 years. After the correction period is
23 completed, these abstracts will be included in a catalog of proposed water rights where they
24 will be subject to a very limited set of objections and ultimately they will be the subject of a
25 final decree. Accordingly,

27 **IT IS ORDERED** vacating order to file responses to amended statements of claimant.
28

1 **Stockpond and Stock and Wildlife watering locations on BLM Grazing Allotment**

2 The process followed in this General Adjudication of Water Rights requires the Arizona
3 Department of Water Resources to prepare a report that analyzes the claims filed by claimants
4 for water rights. A.R.S. §45-256. Any claimant may file objections to a report within a given
5 time period. Thereafter, each claimant who has filed timely written objections shall have a fair
6 and reasonable opportunity to present evidence in support of or in opposition to the report
7 prepared by Arizona Department of Water Resources. *Id.* To comply with the governing
8 statute, the Court has adopted the organizational structure whereby each individual report
9 prepared by the Arizona Department of Water Resources for the San Pedro River Watershed
10 corresponds to a unique contested case number. When a contested case is initiated, the parties,
11 such as the claimant(s) and any objectors, are given notice and have the rights set forth in
12 A.R.S. §45-256 to litigate the claims for water rights analyzed in the particular reports. Claims
13 for water rights should be considered within this established procedural structure.
14
15

16 This contested case was initiated to consider the claims included in five reports: 115-
17 04-10, 115-05-30, 115-05-41, 115-05-44, and 115-05-49. These cases do not include claims
18 to water rights analyzed by the following reports: 115-05-05, 115-05-17, 115-05-18, and 115-
19 05-19. Exhibit B attached to The Arizona Chapter of the Nature Conservancy’s Consolidated
20 Abstract of Statements of Claimant, dated February 15, 2018, lists 32 stockponds and stock
21 watering locations. Appendix B to this Order lists the 32 stockponds and stock watering
22 locations shown on Exhibit B and attempts to identify the relevant watershed file report to the
23 extent possible using upon the information provided. Based upon the public records
24 maintained by the Arizona Department of Water Resources, only one stockpond or stock
25 watering claim listed in Exhibit B appears to be included in the watershed file reports that are
26 involved in this case. That single site is labelled by the Arizona Chapter of the Nature
27
28

1 Conservancy as "Little Windmill" and it may be the subject of Statement of Claimant 39-5533
2 that was assigned to the Bureau of Land Management. The Arizona Department of Water
3 Resources considered Statement of Claimant 39-5533 in watershed file report 115-05-041 but
4 did not assign a potential water right to it.

5 Any filing by The Arizona Chapter of the Nature Conservancy in this case must be
6 limited to only those claims for water uses that are the subject of the watershed file reports
7 being considered in this case. Claims for water uses analyzed in 115-05-05, 115-05-17, 115-
8 05-18, and 115-05-19 will be considered in contested cases specifically initiated for the
9 purposes of considering the claims listed in those reports and the objections filed to those
10 reports.
