This consolidated case consists of the contested cases involving claims for water rights associated with diversions of water from the Pomerene canal for irrigation use. The Pomerene


1 Water Users Association filed a Notice of Termination on August 31, 2018. The St. David
2 Irrigation District has claimed the Pomerene diversion structure and canal. While a number of
3 members of the Pomerene Water Users Association have petitioned and been granted the right to
4 join the St. David Irrigation District, a greater number of members have declined to join the St.
5 David Irrigation District. Given the different positions taken by the landowners, no reason exists
6 for the continued consolidation of the contested cases in this matter to adjudicate water rights.
7
8 Except as subsequently ordered, each contested case will proceed separately.
