It identified three tax parcels. One tax parcel, 104-41-008D, is owned by Karl F. & Patrick J. Dome Rev Living Trust. The other two tax parcels, 104-42-008G and 104-42-008H, are owned by the Estate of Robert MacNeil. By letter dated January 6, 2023, Brooke

1 Ann Meyer, as the personal representative of the Estate of Robert MacNeil, stated that she  
2 intended to pursue claims to rights to water for use on the land included in the Estate.


3 **IT IS ORDERED** that a status conference shall be held to discuss the appropriate
