This contested case was initiated in May 2021. In August 2021, Keith Dinwiddie, son of Edgar and Lorraine Dinwiddie, passed away. It is understood there is currently a property dispute between the estate of Keith Dinwiddie and the widow of Keith Dinwiddie, Ms. Lupita Dinwiddie, regarding the land subject to the potential water rights in question for this case.

During a December 1, 2024, status conference, Mr. Doug Newborn, representing Shelly Scriven who is the personal representative for the Estate of Keith Dinwiddie, stated


1 that he must process a series of quiet title actions on various properties in dispute. Mr.  
2 Newborn went on to state he would send out the letters to Ms. Lupita Dinwiddie by the  
3 end of December 2023. The Court subsequently ordered Mr. Newborn to file a Notice to  
4 the Court when the letters had been sent. As of January 25, 2024, the Court has received  
5 no notice from Mr. Newborn or Ms. Scriven. No water rights can be granted unless the  
6 property dispute is resolved, therefore it is incumbent upon the claimants to resolve this  
7 issue quickly.

8 **IT IS ORDERED** that a Status Report shall be filed by Mr. Newborn by **February**  
9 **9, 2024**, explaining why the quiet title letters have not been sent, or if the letters have been  
10 sent, the date they were sent as well as the expected timeline for resolution of the property  
11 dispute issues.
