Watershed to determine legal rights to water. Other cases in which claims have been made for legal rights to water in the San Pedro River Watershed have been completed, are in the process of determining water rights, or are awaiting initiation. The purpose of the General Adjudication is to determine the rights of those persons who filed statements of claimant for rights to use appropriable water in Arizona. The General Adjudication will also determine water rights in the Upper Salt, Verde, Upper Gila, Lower Gila, Agua Fria, and Upper Santa Cruz watersheds.

In this case, White House Ranch, Mo and Darlene Grenier, and Thomas G. and Karen Ann Baker ("Claimants") collectively filed ten Statements of Claimant for rights to water in Sections 28, 29, 31, and 32 of Township 15S Range 20E. The Arizona Department of Water Resources ("ADWR") investigated the claims. It found potential water rights for four irrigation uses and two domestic uses and prepared Watershed File Report and Zone 2 Well Report 112-14-DAC-001 ("Reports") published in the Final San Pedro River Watershed Hydrographic Survey Report (1991). The Watershed File Report ("WFR") reported a notice of appropriation for irrigation with an 1893 priority date. Statement of Claimant 39-3891 also claims a priority date of 1891. The Watershed File Report 112-14-DAC-001 lists the source of water for the potential water rights as eight wells identified as W01-W08. According to ADWR, all eight wells listed on the WFR are located within the boundaries of the subflow zone of the San Pedro River. A copy of the Reports is attached as Attachment A. A copy of the map of 112-14-DAC-21 001 prepared by ADWR for the Reports is attached as Attachment B with the land associated 22 with this case labeled as "(1)" and "(DAC-1)". 23

The public records of the Arizona 19 Department of Water Resources do not contain an assignment of any of the SOCs. However, 20 21 the public records of the Arizona Department of Water Resources do contain four SOCs filed by 22 Dan White for irrigation use on the property described in the Reports: 39-17888, 39-17889, 39-23 17890, and 39-18120. 




