Vincent. This contested case is one of the many cases in the Arizona General Stream 26 27 Adjudication for the San Pedro River Watershed to determine legal rights to water. Other cases

in which claims have been made for legal rights to water in the San Pedro River Watershed have been completed, are in the process of determining water rights, or awaiting initiation. The purpose of the General Adjudication is to determine the rights of those persons who filed Statements of Claimant for rights to use appropriable water in Arizona. The General Adjudication will also determine water rights in the Upper Salt, Verde, Upper Gila, Lower Gila, Agua Fria, and Upper Santa Cruz watersheds.

In this case, Walter J. Mayshar ("Claimant") filed Statement of Claimant ("SOC") 39-10855 on July 23, 1984 for rights to water for irrigation and domestic use on Parcel 4A in Section 36 Township 17S Range 20E from well registered as 55-505755. The Arizona Department of Water Resources ("ADWR") investigated the claim, which it characterized as a claim for irrigation and stock watering uses, and prepared a report known as Watershed File Report No. 112-17-AC-016 ("WFR") published in the Final San Pedro River Watershed Hydrographic Survey Report (1991). A copy of the WFR is attached as Attachment A.

The SOC includes claims with a priority date of 1983 from a well located in Section 36 T18S R21E. The WFR found no irrigation or domestic watering uses on the land described in the WFR. After ADWR issued the WFR, objections were filed to the findings made in the WFR. The purpose of this case is to consider the claims made for water rights that are the subject of the WFR and resolve the objections to the WFR.

Claimant & Landowner

The WFR identified one SOC relevant to the potential water right: 39-4136. Walter J. Mayshar filed the SOC claiming water for irrigation and stock watering uses. The WFR lists Joseph and Barbara Bring as the owners of the property described as located in the southwest quarter southwest quarter southeast quarter of the Section 36 Township 17S Range 20E. The

records of the Cochise County Assessor indicate that Randy S. Vincent is the owner of the land described in the WFR. Randy S. Vincent owns tax parcel no. 124-24-019. The public records of the Arizona Department of Water Resources do not contain an assignment of the SOC from Walter Mayshar to a successor landowner. A copy of the map prepared by the Cochise County Assessor showing tax parcel no. 124-24-019 is attached as Attachment B.

IT IS ORDERED:

- 1. <u>Contested Case</u>. This contested case shall be known as *In re Joseph K. and Barbara D. Bring* and it will determine appropriable water rights asserted in the Statement of Claimant and objections that were filed to Watershed File Report 112-17-AC-016 published in the Final San Pedro River Watershed Hydrographic Survey Report (1991). Copies of objections can be found under the case name and number on the following website: http://www.superiorcourt.maricopa.gov/SuperiorCourt/GeneralStreamAdjudication/whatsNew.asp
- 2. <u>Litigants</u>. The litigants in this contested case are the Claimant, the current land owner, all persons who filed objections to the WFR, and parties who are allowed to intervene by order.

3. <u>Court-Approved Mailing List.</u>

A. The initial Court-approved mailing list for this case shall include all persons listed on Attachment C to this order. The list may be modified only by filing a motion with the Special Master to amend the Court-approved mailing list. Litigants are responsible for using the current Court-approved mailing list.

- B. A copy of any pleading filed with the Clerk of the Maricopa County

 Superior Court in this case shall be served upon each person listed on the

 Court-approved mailing list.
- C. Claimants wishing to be added or removed from the mailing list shall file a motion with the Special Master. Parties allowed to intervene will be automatically added to the Court-approved mailing list.
- D. The Clerk of the Court will send copies of all minute entries and orders issued in this case to the parties listed on the Court-approved mailing list.

 Upon request, the Clerk of the Court will provide copies by email. Parties may request emailed copies of minute entries and orders by completing and submitting a CONSENT FOR ELECTRONIC RECEIPT OF WATER CASE DOCUMENTS, which is attached as Attachment D.
- 4. <u>Status Conference.</u> An initial status conference shall be held to determine whether the Claimant or current landowners, Randy S. Vincent, intend to pursue claims for rights to appropriable water for irrigation or stock watering use. If no person claiming a water right appears at the Status Conference, then Statement of Claimant 39-4136 and this case will be dismissed and no further action will be taken with respect to the WFR or the objections filed to the WFR.

The Status Conference shall be held on **April 7**, **2022** at **2:00 p.m**. The Status Conference shall be held using the Court Connect program.
