1:30 p.m. This is the time set for a Status Conference before Special Water Master Susan Ward Harris, to determine whether the parties have been able to reach an agreement to resolve the objections to the claimed water rights.

Discussion is held regarding the status of the case. Mr. Bundy reports that he did not contact the National Archives to obtain records to support his claims for water rights. He states that he has spoken to a few of the attorneys listed above and intends to submit two abstracts. He believes that the priority date is prior to 1914 (March 1911).

Laurel Hermann states that she would like to see documentation to show the dates of water use, the quantity of water being used, a map of the property and where it is located with respect to the subflow zone. She states that she needs to see supporting documents to address any abstract that may be submitted by Mr. Bundy. Ms. Hermann reports that she has not been contacted by Mr. Bundy.

Thomas Murphy is in agreement with Ms. Hermann regarding the fact that he needs to review all of the necessary documents to support an abstract that may be submitted by Mr. Bundy. Mr. Murphy states that Mr. Bundy has not contacted him.

Michael Foy states that Mr. Bundy did contacted him. He believes Mr. Bundy should file an assignment of the existing Statement of Claimant.

Sue Montgomery states that Mr. Bundy did contact her. She reports that the Yavapai Nation is willing to review the documents that Mr. Bundy provides in support of his claim.

John Burnside reports that Mr. Bundy has not contacted him. He is in agreement with the other counsel and requests copies of any and all documents that Mr. Bundy is able to gather - in addition to the proposed abstracts - to support his claim, as is Mr. Billingsley.

The Court informs Mr. T.C. Bundy that he should collect the documents requested by counsel, and create a map of the irrigated land and indicate where the wells are located.

The existing Statements of Claimant are in Mr. Bundy's mother's name (Winnifred Bundy). Mr. Bundy is directed to contact Kimberly Parks at ADWR with respect to assigning an existing Statement of Claimant.

Kimberly Parks states that she or one of her staff members will assist Mr. Bundy to create a map of the irrigated land with the correct GPS coordinates to identify the wells on his property.

Mr. Bundy is directed to contact the National Archives and request copies of the homestead affidavits for his land.

Mr. Bundy shall be prepared to provide details about: (1) documents obtained to support his claims; (2) documents provided to objecting parties; (3) documents requested from public entities; and (4) status of map of irrigated land.
