The WFR also includes tax parcel 208-39-010E which the Cochise County Assessor lists as owned by Benson Farm Estates, LLC. A status conference was held in this case 3 on December 2, 2021. Benson Farm Estates, LLC did not appear at the Status Conference. 4 Accordingly, no further action will be taken with respect to tax parcel 208-39-010E. 5
