in which claims have been made for legal rights to water in the San Pedro River Watershed have been completed, are in the process of determining water rights, or are awaiting initiation. The purpose of the General Adjudication is to determine the rights of those persons who filed Statements of Claimant for rights to use appropriable water in Arizona. The General Adjudication will also determine water rights in the Upper Salt, Verde, Upper Gila, Lower Gila, Agua Fria, and Upper Santa Cruz watersheds.

In this case, the trustees of the Mark M. and Marion B. Kartchner Revocable Trust ("Claimant") filed Statement of Claimant ("SOC") 39-13549 on March 30, 1989, for rights to water on land in the south half of the northwest quarter of Section 26 Township 17S Range 20E. The Arizona Department of Water Resources ("ADWR") investigated the claim, which it characterized as a claim for irrigation use and prepared a report known as Watershed File Report No. 112-17-BDD-009 ("WFR") published in the Final San Pedro River Watershed Hydrographic Survey Report (1991). A copy of the WFR is attached as Attachment A.

The SOC claims water supplied by a well located in the NESENW Section 26 T17S R20E for 19.30 acre-feet annually of water for irrigation use with a priority date of 1986. The WFR found no irrigation use on the land described in the WFR. After ADWR issued the WFR, objections were filed to the findings made in the WFR. The purpose of this case is to consider the claims made for water rights that are the subject of the WFR and resolve the objections to the WFR. The public records of ADWR do not show an assignment of the SOC to the successor landowner.

The WFR identified one SOC relevant to the potential water right: 39-13549. The WFR lists Mark and Marion Kartchner as the owners of the property described as located in the south half the northwest quarter of Section 26 Township 17S Range 20E. The records of the Cochise County Recorder indicate Marion B. and Mark M. Kartchner conveyed the property to Cochise Caverns, LLC on November 5, 2001 by warranty deed, recorded as document no. 2001-32050.

The public records of the Cochise County Assessor list the property as tax parcel no. 124-21-009. A copy of the map prepared by the Cochise County Assessor showing tax parcel no. 124-21-009 is included as Attachment B.

IT IS ORDERED:

- 1. Contested Case. This contested case shall be known as In re Mark and Marion Kartchner II and it will determine appropriable water rights asserted in the Statement of Claimant and objections that were filed to Watershed File Report 112-17-BDD-009 published in the Final San Pedro River Watershed Hydrographic Survey Report (1991). Copies of objections can be found under following website: the name and number the case on http://www.superiorcourt.maricopa.gov/SuperiorCourt/GeneralStreamAdjudication/whatsNew.asp
- 2. <u>Litigants</u>. The litigants in this contested case are the Claimants, the current landowner, all persons who filed objections to the WFR, and parties who are allowed to intervene by order.

3. Court-Approved Mailing List.

- A. The initial Court-approved mailing list for this case shall include all persons listed on Attachment C to this order. The list may be modified only by filing a motion with the Special Master to amend the Court-approved mailing list. Litigants are responsible for using the current Court-approved mailing list.
- B. A copy of any pleading filed with the Clerk of the Maricopa County

 Superior Court in this case shall be served upon each person listed on the

 Court-approved mailing list.

- C. Claimants wishing to be added or removed from the mailing list shall file a motion with the Special Master. Parties allowed to intervene will be automatically added to the Court-approved mailing list.
- D. The Clerk of the Court will send copies of all minute entries and orders issued in this case to the parties listed on the Court-approved mailing list.

 Upon request, the Clerk of the Court will provide copies by email. Parties may request emailed copies of minute entries and orders by completing and submitting a CONSENT FOR ELECTRONIC RECEIPT OF WATER CASE DOCUMENTS, which is attached as Attachment D.
- 4. <u>Status Conference.</u> An initial status conference shall be held to determine whether the current landowner, Cochise Caverns, LLC, intends to pursue claims for rights to appropriable water for irrigation use. If no person claiming a water right appears at the Status Conference, then Statement of Claimant 39-13549 and this case will be dismissed and no further action will be taken with respect to the WFR or the objections filed to the WFR.

The Status Conference shall be held on March 17, 2022 at 2:40 p.m. The Status Conference shall be held using the Court Connect program. Instructions for Court Connect are attached as Attachment E. 
