DESCRIPTIVE SUMMARY: Statements of Claimant 39-5471 and 39-5472 are dismissed. No further action shall be taken with respect to the objections to Watershed File Report and Zone 2 Well Report 112-17-DCA-010.

This contested case consists of claims for right to water set forth in Statements of Claimant 39-5471 and 39-5472 filed by Arnold C. Garcia. The Statements of Claimant were assigned to the Nature Conservancy on September 13, 1992. On March 25, 1993, the Arizona Chapter of the Nature Conservancy assigned the Statements of Claimant to the United States c/o BLM, Safford District Office. Watershed File Report and the Zone 2 Well Report 112-17-DCA-

1 010 (collectively "Report"), published in the Final San Pedro River Watershed Hydrographic
2 Survey Report (1991), stated that Arizona Department of Water Resources investigated the
3 claims, found irrigation, stockpond, and stock reservoir uses. A number of objections were filed
4 to the Report.

5 By Order dated January 23, 1995, this contested case was consolidated with *In re St.*
6 *David Irrigation District*, contested case W1-11-1675. Subsequently, this contested case was
7 consolidated with *In re San Pedro Riparian National Conservation Area*, contested case W1-11-
8 232. See Case Management Order, September 26, 2006.

9 During the Status Conference on August 22, 2022 in W1-11-0232, the United States
10 represented that it did not intend to pursue either of the Statements of Claimant that were the
11 subject of the Report. Accordingly,

12 **IT IS ORDERED** that this contested case is severed from *In re St. David Irrigation*
13 *District*, contested case W1-11-1675.

14 **IT IS ORDERED** that this contested case is severed from *In re SPRNCA*, contested case
15 W1-11-0232.


16 **IT IS FURTHER ORDERED** that Statements of Claimant 39-5471 and 39-5472 are
