# Courtroom: CCB 301

10:00 a.m. This is the time set for a Status Conference before Special Water Master, Sherri Zendri.

The Court inquires of Ms. Wendel if there is an update for the Schwennesens.

Mr. Michael provides an update. They have not had contact with the Heartquists. The Schwennesens are claiming only de minimus in-stream use. They are waiting on historical documents from the national archive to determine a priority date. A Statement of Claim has been drafted.

The Court confirms that the Heartquists are not in attendance. The Court will set another Status Conference in approximately 60 days to receive an update from the Heartquist's and an update on the Schwennesen's claim.

Ms. Wendel states that there are two other parcels belonging to the Schwennesens that are adjacent to the property currently being litigated. The parcels numbers are 300-27-005(C) and 300-27-005(B).

The Court states that there may be some problems with the current map.

Ms. Sparks states that he was unable to clearly hear Ms. Wendel.

The Court recaps what Ms. Wendel said. The Court inquires of Ms. Parks if she knows which two other cases are connected to this case and if this case involves the piece of property belonging to the Bureau of Land Management that no one claimed.

Ms. Parks states that is a different case and offers to create a new map.

The Court will look through the maps and determine if a new map needs to be created. The Court inquires if Ms. Wendel has any concerns with the current maps and if they can move forward with a de minimus in-stream wildlife claim with the current maps.

Ms. Wendel affirms that the current maps should be sufficient.

The Court states that one of the other connected cases will have a Status Conference in a few days.

The Court will set another Status Conference in approximately 60 days to discuss the appropriateness of the maps and to receive updates from both property owners.
