
IT IS FURTHER ORDERED:


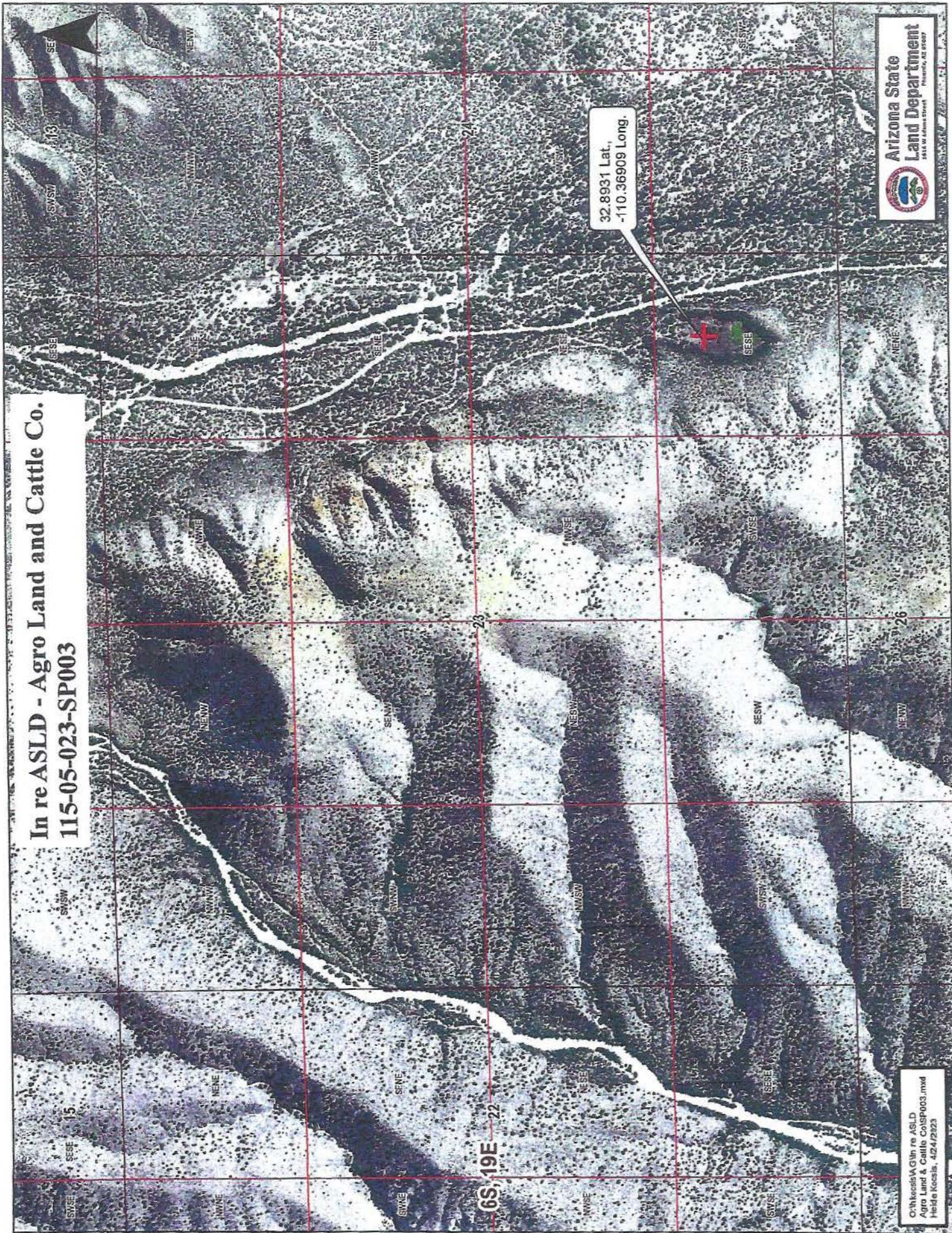
