DESCRIPTIVE SUMMARY: The Special Master grants the request of the United States to extend by 45 days the scheduled dates of the current briefing schedule.

The United States has requested that all the scheduled dates of the current briefing of initial issues be extended 45 days due to an internal clerical error that resulted in the United States missing its filing of initial disclosures. As no objections to the request have been filed, and we are in the first stage of this briefing, the request for an extension of time of 45 days for all scheduled dates will be granted.

- 3. Paragraph 9(B) (Discovery) to provide that parties may commence formal discovery on or after **May 3, 2010**, but prior thereto may, and are encouraged, to engage in informal discovery.
- 4. Paragraph 9(C) to provide that all discovery including depositions shall be completed by **October 25, 2010**.
- 5. Paragraph 10 (Expert Reports) to provide that on or before **July 29, 2010**, all parties shall exchange expert reports that a party considers relevant to the issues designated for briefing.
- 6. Paragraph 11 (Motions) to provide that on or before **December 30, 2010,** any party in this case may file the appropriate motion that presents the party's position concerning any of the designated issues. The succeeding two sentences remain the same.
- 7. Paragraph 12 (Responses) to provide that responses to all motions shall be filed by **February 17, 2011**.
- 8. Paragraph 13 (Replies) to provide that replies to all motions shall be filed by **May 2, 2011**.
- 9. The reference to deadlines in Paragraph 14 (Statement of Position) shall include the foregoing new deadlines.
