1 In addition, objections must specifically address the director's recommendations regarding
2 particular water rights claims or uses investigated and state in clear and concise language the
3 particular factual and/or legal reasons for the objections and describe the evidence to support
4 those reasons. None of the listed objections listed above were timely filed and none
5 included specific objections to the water right claims or uses that are the subject of the Hopi
6 HSR.

8 In letters accompanying the form of Objection filed by the two limited liability
9 partnerships and by Charles and Jacquelyn S. Bebee, no objection is made to the Hopi HSR,
10 but a request is made to protect the Objector's water rights. Objections are not a substitute
11 for filing Statements of Claimant with the Arizona Department of Water Resources to assert
12 water rights.¹

14 **IT IS ORDERED** that the objections filed by Bear Ridge Resort, LLP, The New
15 Sundance LLP, Charles and Jacquelyn S. Bebee and Raymond Turley are hereby dismissed
16 with prejudice.
