The Atkinson Trading Company, Inc., a claimant, timely filed a Statement of Objection in this contested case on June 14, 2016. The pleading contains no objections to the Final Hopi Hydrographic Survey Report (“Hopi HSR”) prepared by the Arizona Department of Water Resources, dated December 18, 2015. Pursuant to A.R.S. §45-256(B), objections must specifically address the recommendations of the director of Arizona Department of Water Resources regarding particular water right

1 claims or uses investigated. The Statement of Objection does not comply with
2 A.R.S. §45-256(B).

3 The Comments attached to the Statement of Objection request the right to
4 receive notice of and to participate in the court proceedings that resolve the
5 objections to the Hopi Reservation HSR. Accordingly, the Comments will be
6 accepted as a motion to be included on the Court's Approved Mailing List and a
7 Motion to Intervene.
