#### WHAT IS SQUATTING?

Basically, squatting means getting into a house or flat that is <u>empty</u> and making it your home. Like all other households, squatters have the right to essential services such as electricity, water, post, gas, rubbish collection and so on. Squatting means using empty property to live in, empty property that would otherwise just rot away.

#### IS IT LEGAL?

Yes, squatting is legal. The only time you are committing a criminal offence is if you cause damage when getting into the empty property. However, it is very difficult to prove this in court so very few people are actually charged. The important thing that you must remember is to get in quickly and quietly, causing as little damage as possible.



#### WHO ARE STOKE NEWINGTON HOUSING ACTION?

Stoke Newington Housing Action is made up of squatters who are committed to helping people escape the total poverty of homelessness and bad housing. We can supply:-

1. an up-to-date list of empty houses and flats;

2. practical help on how to gain entry into empties;

3. advice on gas/electricity problems;

4. basic legal advice;

5. 'The Squatters' Handbook' - a helpful and very practical guide to all aspects of squatting; .

6. other more general information;

But Stoke Newington Housing Action is not an 'estate agents' - we want to help people to help

themselves and we are also committed to challenging the causes of the housing crisis that forces people into squatting.

#### SQUATTING IN HACKNEY

The majority of squatted houses in Hackney are owned by the council. Some are houses, but most are found on the many estates in the borough. Many have been empty for months and often years, which means that sometimes they're in a bad state of disrepair. The time that you can get in a squat can vary from between 6 months to a year - or even longer. On the whole, the police in Hackney recognise squatting as a symptom of the housing crisis and so rarely intervene. It is also very possible to squat in privately owned places and Housing Association houses (as long as, of course, they're empty).

#### HACKNEY COUNCIL

Due to a combination of central government cuts and complete inefficency, there are over 3000 empty council homes in Hackney. As well as this, there are nearly 5000 empty homes here that are owned by property speculators and Housing Associations. Added to this are the many thousands of people who are homeless or in very poor housing. Squatting is a short term solution to the housing crisis for many people.

Some people say that, it's "queue jumping" but that ignores the basic reality of the housing situation homelessness plus empty homes equals a lot of squatting. It is the government officials, property speculators and the councillors who are the guilty ones, not squatters - because they are the ones responsible for the housing crisis.



#### A GROWING SOLUTION IN TIMES OF HARDHSIP

Finding a decent home is becoming harder and harder unless you've got loadsamoney! Not only is squatting a solution to the housing crisis, but it also shows that we don't have to rely on rich landlords or useless councils. It's time that we started to take things that we need for ourselves. It is important that we share the knowledge we gain with as many people as possible. We can all help by making lists of empty property, by helping people get in, by getting involved with Stoke Newington Housing Action or other squatters/housing act-



ion groups. Squatting is not the problem - the real problem is the housing crisis, the empty homes, the fact that homes are seen in terms of profit and power, not real human need.

If you want to find out more about squatting or are looking for a squat, come to our regular meetings every Monday from 6pm to 8pm at The Old Fire Station (61 Leswin Road, Stoke Newington, N16, just off Stoke Newington High Street). 

## 121 CENTRE : WE'RE STILL HERE!

The future of the long-running 121 anarchist squat centre hangs in the balance. On January 14th, after 18 years of occupation, Lambeth Council won a possession order in Lambeth County Court, entitling them to evict the squatters after 14 days. The 121 Collective had contested that the council had lost title to the building, under the 12 year adverse possession principle. The council argued that since the squatters had fought a 1983-5 court case on the grounds that they were licensees, they had recognised the council's title to the property. This renders the 12 year clause irrelevant, as you are not allowed to recognise the council's title to they have any right to evict you or grant you a licence, tenancy etc. Since letters were exchanged in June 1985, 11 years, 11 months and 2 weeks before the latest proceedings began, the Judge Cox decided the case was still going, although it had been adjourned and not come back to court for over 12 years. All legal arguments by the 121 and learned friends were

On Friday February 5th the occupiers of 121 were told by the bailiffs that they were coming on to evict us on Monday 8th. Over the weekend we spread the word and prepared ourselves, flyposting the area, distributing newssheets and phoning friends and allies.

For the tast 3 weeks, the 121 Collective and friends have been producing publicity: leaflets, letters, emails, the South London Stress, posters, a booklet. We've campaigned around the area, drawing links between the eviction of 121 and the clearance of squatters from the area, the gradual gentrification of Brixton and the slow destruction of its street culture and communities. As well as increasing council cuts, sell-offs, dubicus redevelopments. This has achieved us some support, leading us to interesting conversations and ideas about future actions.

#### INTERNATIONAL SUPPORT

Meanwhile emails were being sent from supporters all over the country and the world to the council, demanding the eviction be stopped. The council leader Jim Dickson replied that the council needed the money from selling off the 121 building to help do up Brixton for the good of the locals... yeah yeah.

#### CAPPUCINO COUNCIL GIVES US FROTH

Much of the City Challenge money spent between in the last few years has done little for the locals but allowed the middle class to colonise Brixton's Town Centre and push many of us out of our houses, our pubs, and future plans intend to knock down parts of the market and shops too. (Not counting large amounts paid as fat salaries to a range of professional community-wreckers, or that have just vanished. Where did all the money for the tube development go?) Many people are a bit suspicious of it all.

#### E-DAY?

Monday morning, at 7am, we were out in the street. The 121 had been barricaded against the bailiffs. When the police started sniffing around, we barricaded the street around 121, setting off our air-raid siren and starting up a sound system.

Around 70 of us held the street for about 2 hours. However the cops were a bit confused. Chief Inspector Craggs approached us, and in negotiations(with most of us) told us he had already called off the eviction because of public order issues. He was being very polite, even cracking jokes. The bailiffs, he said, had been planning to come down with a few builders and kick the door in. Not really ready for resistance. We weren't going to be evicted that day - or for a few days after, he claimed.

We held several meetings of all present, discussing what to do. A council officer, from the corporate property dept., came to confirm Scraggs' words, so did Brixton top cop Superintendent Stout. So eventually did the bailiffs. It rang true. The cops and the council said they were meeting the following day to discuss the 121. We said we wanted to be involved in any discussions. Crabs and Snout said no, but they would talk to us afterwards.

#### TAKE US TO YOUR LEADER

We decided to press the issue. We took down the street barricades, as the bailiffs weren't coming and the cops were about to come and do it anyway. We felt we had to persuade the council we were determined to defend 121. Leaving a group in the building 45 of us proceeded to storm Lambeth Town Hall, running through the building, looking for the Council Leader's office. We got there, but Jim Dickson was out. 2 security guards & an office worker,

assaulted a few of us, overdoing their job for no good reason since we didn't want to fight them. The cops arrived, broke through the office door and chucked us out, handcuffing 5 or 6 people and being generally less pleasant than they'd been earlier on at our barricade. Higher-up coppers may be politicians but your ornery bobby likes nothing better than kicking ass. We were booted out without arrests.

#### We'd proved that their building is easier to get into than ours...

All in all the day was a good laugh, and showed that the council and the police are wary of the 121 and what trouble we can cause. It may be they are stalling, while they prepare a large-scale assault. At the same time as we were blocking the street, 3 large local squats who were waiting for the bailiffs were evicted nearby (See elsewhere). On Monday afternoon, a council officer rang the 121. He said the Council leader was prepared to meet us, at our convenience, to discuss what we wanted. We arranged to meet them 2 days later.

#### SUPPING WITH THE DEVIL

Three of us went to meet with Council Leader Jim Dickson, armed with a mandate from the 121 Collective. We were prepared to ask for a deal, where we got to keep the building, acknowledging the council as our landlords, but paying no rent, & them not responsible for repairs. We knew we could not afford a proper tenancy. This seemed the only option. (Lambeth and other councils have made this kind of deal before). If they were willing to negotiate we might as well oush it.

Slim Jim was not willing to negotiate. He restated what he'd said in replies to the many emails supporters had sent to the council: they had to sell the building to raise vital funds for their program to improve Lambeth services. The same services being cut as we speak: schools, libraries, housing. He offered us the opportunity to pay an unaffordable amount of cash for one of a number of Lambeth buildings in the boonies - just where they want us, miles away from Brixton, our home, where property is hot and its only a short walk to Slippery Jim's office (open all hours). We took the list of empties though: cheers Jim, we'll pass them on to people

made homeless by your policies.

The whole meeting for Oily Jim was just a Public Relations exercise - covering his back. He only got the tiniest bit rattled when we suggested that us resisting the eviction might cost them more than they'd get from the auction. We never had much hope of getting something out of the negotiations, and we were right. We left in the same position as we went in - waiting for the bailiffs and ready to resist.

THE LATEST: Another eviction date was set for Friday Feb 12th, but the council withdrew this. They realise now they need to plan a bigger operation.

121 Railton Road was squatted in December 1980. Since 1981 it has been used as an anarchist bookshop and information centre, a cheap cafe and social space, a meeting point for local & political groups, provided offices for magazines, newspapers and publishing collectives; a late night club and gig venue. From the building people have been involved in many campaigns & social struggles, including supporting the Miners and Printers' strikes in the 80s, housing and squatting struggles, anti-racist & anti-fascist organising, supporting prisoners here & abroad, fighting the poll tax, women organising for themselves: against council cuts, evictions and redevelopments, anti-benefit cuts - to name but a few. Brixton Squatters Aid from 1982 has given

help & advice & lent tools to 1000s of people squatting in abandoned property in Lambeth. 121 has been a space for people to meet, eat, talk, & dance, a space under the control of those who use it, not tied to or funded by the council or any institution, free of interference from bureaucrats & business. This is why the council want us out because we've never hesitated to attack the powers that be when they deserve it, & we have shown you don't need the council or any other power over people's lives.

#### UNDER ATTACK

121 has survived eviction threats before, as well as a police raid in 1984, press lies about us & an attempt by fascists to burn the centre down in 1993. This time the council are determined to kick us out. But we won't go quietly!

We are blockading the street to stop them getting to the building. Come down & help out! Even if we are evicted, we will not go away. The struggles we have been involved in will continue! We live here and will find other spaces to organise from. In this society, where profit rules and people are forced to work for the rich and many of us live in misery or poverty, most of us are forced to struggle every day.

LOOK, DEAR, IT'S A MAN JUST SITTING THERE-ON THE WALL! MAY BE WE SHOULD INFORM THE E AUTHORITIES TOGET RID OF HIM, AND THE WALL AS WELL!

#### **A BRIGHTER BRIXTON?**

Another reason why the council want us out, is because in alliance with property developers they are trying to change the face of Brixton. They say this is all to improve the lives of people who live here. Alot of the changes however are aimed at getting rid of people the council & the police see as a threat, or who don't fit in to the image of Brixton they want to portray. So much of the Brixton street culture has been harassed off the streets, 1000s of squats have been evicted, & housing co-ops are following. Rents/house prices have risen: pushing people out of the area. Lambeth are selling off 100s of houses, worsening the squeeze. Local pubs, especially Black or Irish pubs like the Atlantic, the Coach & Horses, Brady's, have closed & replaced by

up-market bars aimed at yuppies. Drinking in the street has just been banned under a local bylaw. So if we can't afford to drink in the poncy bars, they want us off the street - out of sight. CCTV cameras watch our every move, not stopping crime as they claim, but driving it

away from the showpiece 'Town Centre' into our estates & streets. A big development is planned above the tube that will destroy much of the market & local shops. Meanwhile many community spaces, advice centres & services are run into the ground or cut completely.

The kind of Brixton the council want is where we do as we are told, don't cause trouble as our lives get worse, or can't afford to go out, or even to live here. We at 121 won't play.

We will continue to take action: against the council: against developers and businessmen dest roying our area. We will organise drink-ins in the street. We will continue to squat empty houses. We will support people fighting cuts in services, opposing development, resisting police abuse. We'll take whatever steps are necessary. We are only one group of people. But there's



1000s of us in Lambeth, all in the same boat. If we work together, despite our many differences, there's alot we can do.

## **SQUATTERS PLEDGE** Life for pervert could be released in 40 months

CAMBERWELL: A maniac given life last week for a second sex attack on vulnerable girls could be out in just 40 months.

Colin McCallam, 39, indecently assaulted a 13year-old girl at his flat in Denmark Hill, in 1987.

Then last April the pervert, who has spent time in mental hospitals, raped a 19-year-old autistic girl in west London. He was given life at the Old Bailey on Friday.

McCallam was jailed for 18 months for the 1987 Camberwell attack. Then in 1990 he got five years for a machete attack in a packed pub, and then in 1997 he tried to tear one cop's eyes out as he bit another on the arm as they tried to arrest him. He got nine months.

McCallam, now of Hanwell, west London, instantly knew his last victim was autistic and soon deduced she was a virgin.

The judge fixed a minimum release date of only 40 months, arguing the dangerous pervert had already served time on remand.

#### War crime trial starts

BERMONDSEY: The first war crimes trial this country has began at the Old Bailey.

Anthony Sawoniuk, 77, of Cadbury Way, denies murdering four Jews as part of Hitler's devastating final solution.

The plump pensioner is said to have killed the two men and two women as part of his role as a Nazi-appointed police officer in his native town on the Polish-Belorussia border.

The jury will spend four days in the town to see the sites where the alleged murders took place.

The case is being brought under the 1991 War Crimes Act.

## Anarchists invade town hall and rife through files

SQUATTERS caused traffic chaos when they barricaded a busy main road with rubbish bins and old washing machines.

Fearing bailiffs were about to evicted them, supporters of Save The 121 Centre blocked off Railton Road, Brixton, at 8am yesterday.

While about 100 anarchists were involved in a stand-off across the barricades with police, 30 of their number stormed the town hall in Acre Lane, Brixton,

They evaded security to get into the Labour group office where they emptied files from Lambeth Council leader Jim Dickson's desk into the bin.

They had to be removed by police as there were too many of them to be ejected by the council's own security staff.

Back at Railton Road the squatters were still refusing to be evicted from the building that they have occupied for 18 years.

An international campaign has been launched to save the centre

A spokesperson for the protesters said, "The bailiffs turned up but they didn't expect this. Right now the top man from Brixton is saying we won't be evicted for the next two days."







## 121 CENTRE : WE'RE STILL HERE!

The future of the long-running 121 anarchist squat centre hangs in the balance. On January 14th, after 18 years of occupation, Lambeth Council won a possession order in Lambeth County Court, entitling them to evict the squatters after 14 days. The 121 Collective had contested that the council had lost title to the building, under the 12 year adverse possession principle. The council argued that since the squatters had fought a 1983-5 court case on the grounds that they were licensees, they had recognised the council's title to the property. This renders the 12 year clause irrelevant, as you are not allowed to recognise the council or acknowledge they have any right to evict you or grant you a licence, tenancy etc. Since letters were exchanged in June 1985, 11 years, 11 months and 2 weeks before the latest proceedings began, the Judge Cox decided the case was still going, although it had been adjourned and not come back to court for over 12 years. All legal arguments by the 121 and learned friends were rejected. Leave to appeal was refused.

On Friday February 5th the occupiers of 121 were told by the balliffs that they were coming on to evict us on Monday 8th. Over the weekend we spread the word and prepared ourselves, flyposting the area, distributing newssheets and phoning friends and allies.

For the last 3 weeks, the 121 Collective and friends have been producing publicity: leaflets, letters, emails, the South London Stress, posters, a booklet. We've campaigned around the area, drawing links between the eviction of 121 and the clearance of squatters from the area, the gradual gentrification of Brixton and the slow destruction of its street culture and communities. As well as increasing council cuts, sell-offs, dubious redevelopments. This has achieved us some support, leading us to interesting conversations and ideas about future actions.

#### INTERNATIONAL SUPPORT

Meanwhile emails were being sent from supporters all over the country and the world to the council, demanding the eviction be stopped. The council leader Jim Dickson replied that the council needed the money from selling off the 121 building to help do up Brixton for the good of the locals... yeah yeah.

#### CAPPUCINO COUNCIL GIVES US FROTH

Much of the City Challenge money spent between in the last few years has done little for the locals but allowed the middle class to colonise Brixton's Town Centre and push many of us out of our houses, our pubs, and future plans intend to knock down parts of the market and shops too. (Not counting large amounts paid as fat salaries to a range of professional community-wreckers, or that have just vanished. Where did all the money for the tube development go?) Many people are a bit suspicious of it all.

#### E-DAY?

Monday morning, at 7am, we were out in the street. The 121 had been barricaded against the bailiffs. When the police started sniffing around, we barricaded the street around 121, setting off our air-raid siren and starting up a sound system.

Around 70 of us held the street for about 2 hours. However the cops were a bit confused. Chief Inspector Craggs approached us, and in negotiations(with most of us) told us he had already called off the eviction because of public order issues. He was being very polite, even cracking jokes. The bailiffs, he said, had been planning to come down with a few builders and kick the door in. Not really ready for resistance. We weren't going to be evicted that day - or for a few days after, he claimed.

We held several meetings of all present, discussing what to do. A council officer, from the corporate property dept., came to confirm Scraggs' words, so did Brixton top cop Superintendent Stout. So eventually did the bailiffs. It rang true. The cops and the council said they were meeting the following day to discuss the 121. We said we wanted to be involved in any discussions. Crabs and Snout said no, but they would talk to us afterwards.

#### TAKE US TO YOUR LEADER

We decided to press the issue. We took down the street barricades, as the bailiffs weren't coming and the cops were about to come and do it anyway. We felt we had to persuade the council we were determined to defend 121. Leaving a group in the building 45 of us proceeded to storm Lambeth Town Hall, running through the building, looking for the Council Leader's office. We got there, but Jim Dickson was out. 2 security guards & an office worker,

assaulted a few of us, overdoing their job for no good reason since we didn't want to fight them. The cops arrived, broke through the office door and chucked us out, handcuffing 5 or 6 people and being generally less pleasant than they'd been earlier on at our barricade. Higher-up coppers may be politicians but your ornery bobby likes nothing better than kicking ass. We were booted out without arrests.

We'd proved that their building is easier to get into than ours...

All in all the day was a good laugh, and showed that the council and the police are wary of the 121 and what trouble we can cause. It may be they are stalling, while they prepare a large-scale assault. At the same time as we were blocking the street, 3 large local squats who were waiting for the bailiffs were evicted nearby (See elsewhere). On Monday atternoon, a council officer rang the 121. He said the Council leader was prepared to meet us, at our convenience, to discuss what we wanted. We arranged to meet them 2 days later.

#### SUPPING WITH THE DEVIL

Three of us went to meet with Council Leader Jim Dickson, armed with a mandate from the 121 Collective. We were prepared to ask for a deal, where we got to keep the building, acknowledging the council as our landlords, but paying no rent, & them not responsible for repairs. We knew we could not afford a proper tenancy, This seemed the only option. (Lambeth and other councils have made this kind of deal before). If they were willing to negotiate we might as well push it.

Slim Jim was not willing to negotiate. He restated what he'd said in replies to the many emails supporters had sent to the council: they had to sell the building to raise vital funds for their program to improve Lambeth services. The same services being cut as we speak: schools, libraries, housing. He offered us the opportunity to pay an unaffordable amount of cash for one of a number of Lambeth buildings in the boonies - just where they want us, miles away from Brixton, our home, where property is hot and its only a short walk to Slippery Jim's office (open all hours). We took the list of emptles though: cheers Jim, we'll pass them on to people made homeless by your policies.

The whole meeting for Oily Jim was just a Public Relations exercise - covering his back. He only got the tiniest bit rattled when we suggested that us resisting the eviction might cost them more than they'd get from the auction. We never had much hope of getting something out of the negotiations, and we were right. We left in the same position as we went in - waiting for the bailiffs and ready to resist.

THE LATEST: Another eviction date was set for Friday Feb 12th, but the council withdrew this. They realise now they need to plan a bigger operation. 121 still needs support! Call in, or ring us on 0171 274 6655/ 0171 978

Everyone knows that the numerous CCTV cameras dotted around Brixton and Lambeth are useless in preventing anti-social orimes, but a recent spate of unsolved rapes and muggings have demonstrated that the cameras are also useless in solving them. ## Brought To Book?

"Lambeth's libraries are miserable, uninspiring, poorly maintained... Lets be honest about is Lambeth has the worst libraries in Britain."-Toady Torren Smith, Council Chair of the Environment, January 1999.

Eight months ago the council put forth the bizarre idea that by closing a number of Lambeth's Libraries they would somehow be able to provide a better library service. This brilliant concept went along with the idea that closing schools would lead to better education, that closing playgrounds would give kids more places to play, that closing disabled services would mean more resources for the disabled, etc. Meaningless terms like "Centres of Excellence" were thrown about and a new "tough" Labour crony Big Frankie Quigg was given the £100 000+ a year job of doing the job on Lambeth's library staff and users.

In the time since the council declared it's "National Year of Reading in Lambeth" we haven't had many new books to read and Lambeth remains the borough with the fewest books, CDs and videos per resident. Library staff are still being blamed by councillors for the neglect of previous council administrations and the fact that New Labour won't spend our money on services that we want. The only new thing seen round the libraries (other than the continuing closure programme) are the much touted private IT centres. These centres, propped up with residents' money and sucking up the little cash left in the library budget, are more expensive than most other internet providers. If Croydon library can provide a free internet service for its users then why are people in Lambeth expected to pay £5 an hour?

Why? Because the council doesn't give a shit

about community services. At the beginning of the year many people saw that the council's library hype was just a cover for sacking staff and closing libraries. So far protests have stopped the council from going too far with their dodgy plans. We need to keep up the effort.

Latest news is that the Council have reprieved Durning Library indefinatly and the other 4 will be kept open until next April, a case of Jim Dickson not waiting to tarnish his already turdy reputation more before he retires in the coming months, and you know where he can shove his golden handshake.
