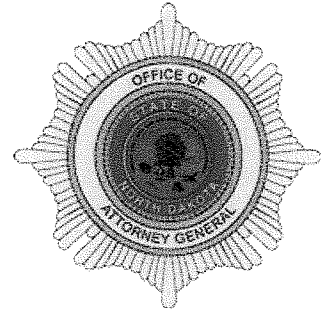

**BACKGROUND**

1. The Attorney General of North Dakota has a reasonable basis to believe Respondent has engaged in, and is engaging in, acts or practices declared unlawful by N.D.C.C. ch. 51-12, commonly referred to as the "False Advertising Law" and N.D.C.C.

ch. 51-15, commonly referred to as the “Consumer Fraud Law.” It is necessary and appropriate in the public interest and for the protection of consumers to restrain Respondent’s unlawful acts or practices.

2. Respondent, individually and by and through his agents, is doing business under some or all of the names identified above, and has engaged in violations of North Dakota law by: 1) making, publishing, disseminating, circulating, broadcasting, or placing before the public, or directly or indirectly causing to be made, published, disseminated, circulated, broadcasted, or placed before the public in a newspaper, or other publication, or in the form of a book, notice, handbill, poster, bill, circular, pamphlet, tab, label, letter, television, or radio broadcast, placement on the internet, or in any other way, an advertisement or webpage that contains assertions, representations, or statements of fact that are untrue, deceptive, or misleading in violation of N.D.C.C. § 51-12-01; and 2) acting, using, or employing deceptive acts or practices, fraud, false pretense, false promise, or misrepresentations, with the intent others rely thereon in connection with the sale or advertisement of any merchandise in violation of N.D.C.C. § 51-15-02.

3. Steven Robert Engebos’s last known address is 910 Laverne Dr., Green Bay, WI 54311-5938. Respondent also has resided at 525 Main Ave., #131, West Fargo, ND 58078 and 3825 9<sup>th</sup> Ave. S., Fargo, ND 58103. Additionally, Respondent also falsely informed a Wisconsin law enforcement agency that he resides at 111 1<sup>st</sup> Ave., Kathryn, ND 58049, which is a nonexistent and fictitious address. Respondent purports to operate the businesses Great Plains Moving and Logistics, Integrity Movers, and IDIS.

4. Respondent, doing business as Great Plains Moving & Logistics, Integrity Movers, and IDIS, is in the business of soliciting and selling merchandise, including moving services. Respondent, or Respondent's agents on Respondent's behalf, solicited North Dakota customers.

5. Respondent disseminated an advertisement that contained assertions, representations, or representations of fact which were untrue, deceptive, or misleading, regarding the moving services Respondent was advertising or offering to the public in violation of N.D.C.C. § 51-12-01.

6. Respondent through written and oral representations made by Respondent, his agents, employees, or representatives, has made untrue, deceptive, and misleading representations, or has engaged in deceptive acts or practices, with the intent that others rely thereon, in violation of N.D.C.C. § 51-15-02.

7. On July 28, 2015, Theodora Degenstein contracted with Respondent, doing business as Integrity Movers, to assist her and her daughter move from their apartment to another location. Respondent supplied U-Haul pods that were filled to capacity; as a result, a worker named "Jeff" offered to store Ms. Degenstein's property at his home for no cost. Thereafter, Ms. Degenstein found herself unable to reach Respondent who retained possession of her property after failing to complete the move.

8. On August 20, 2015, Ms. Degenstein filed a theft report with the Fargo Police Department.

9. On September 1, 2015, after many previous attempts, Fargo Police Department Detective Erickson was able to reach Respondent via the telephone number that Ms. Degenstein provided in her report. During the telephone conversation,

Respondent told Detective Erickson that he was "Paul Peterson," a worker for Integrity Movers and that Respondent was actually in Florida visiting his sick mother.

10. On September 2, 2015, Detective Erickson spoke with Respondent at the Days Inn, 525 Main Ave. E., # 131, West Fargo, ND 58078. Respondent admitted that he lied to Detective Erickson by representing himself as "Paul Peterson," that it was actually him on the telephone, and that he had not visited Florida recently. Respondent did not disclose information related to his worker "Jeff," though Detective Erickson did locate Ms. Degenstein's property at the residence of Jessica Hanson and Jeffery Smith. They agreed to return Ms. Degenstein's property to her, though she was not able to recover a freezer that she paid Respondent to move with her other property.

11. Respondent, doing business as Integrity Movers, did not move Ms. Degenstein's property as he was paid to do.

12. On October 28, 2015, Respondent was charged with one count of False Information to Law Enforcement in case no. 09-2015-CR-3595. Respondent entered a guilty plea on November 20, 2015.

13. On April 5, 2016, Lynnette Frank contracted with Respondent, doing business as Great Plains Moving & Logistics, to perform moving services for her. In correspondence sent from his greatplainslogisticsllc@outlook.com e-mail address on March 31, 2016, Respondent told Ms. Frank that he booked a 26 foot Penske truck for April 16, 2016 in order to perform her move. Respondent said that he would provide two men and estimated that the job would take approximately eight hours. Respondent quoted \$960.00 to perform the work and solicited an advance payment of \$480.00.

14. Respondent did not arrive to perform Ms. Frank's move on April 16, 2016. Respondent claimed that he was at a funeral and was not in North Dakota. Respondent promised that he would provide a refund to Ms. Frank by FedEx. Ms. Frank did not receive a FedEx delivery providing her the promised refund. Subsequently, Respondent stated in a text message to Ms. Frank that he would provide a refund to her. Respondent did not provide the refund. Ms. Frank then contacted Penske Truck Rental and learned that, while Respondent frequently reserves trucks with them, he never shows up to retrieve them.

15. On September 21, 2016, Sarah Juneau contracted with Respondent, doing business as "IDIS, Inc./Great Plains Moving & Logistics," to move her possessions from Security Self Storage on Main Street in West Fargo, ND to a residence in Fargo, ND. The contract was concluded via e-mail, with Respondent using the e-mail addresses [idintegritysolutionsinc@live.com](mailto:idintegritysolutionsinc@live.com) and [greatplainslogisticsllc@outlook.com](mailto:greatplainslogisticsllc@outlook.com). Gary Hoffart, who appears to have been working with Respondent, was carbon copied on the e-mail exchange between "IDIS, Inc./Great Plains Moving & Logistics" and Ms. Juneau at the e-mail address [ghoffart@gmail.com](mailto:ghoffart@gmail.com).

16. In the prepared work order, Respondent promised that the business would "load/pack/drive and unload trailer and truck from Security Self Storage on Main West Fargo ... and deliver unload and install [sic]." Respondent indicated in the work order that the estimated time to complete the work would be three hours and that they would perform the work on September 29, 2016 beginning at 7:00 p.m. Respondent provided a quote of \$210.00 to perform the move, plus \$32.00 for gas.

17. In this instance, Gary Hoffart arrived with another worker to perform under the contract. Mr. Hoffart brought a very small trailer and not the large truck that Respondent told Ms. Juneau that was available and that she indicated would be required. Gary Hoffart identified himself as “the other Steve,” and not the Steve that she had corresponded with via e-mail. Gary Hoffart asked Ms. Juneau’s friend to purchase a cable so that the lights on the trailer could be illuminated while driving because Gary Hoffart did not have one. Gary Hoffart frequently inquired to Ms. Juneau what was in the boxes she was moving. Because Respondent did not supply the large trailer he promised and that was requested, the move took several hours. Additionally, because Gary Hoffart and his worker were generally unprepared, Ms. Juneau’s friend performed most of the moving. Though contracted to do so, neither Gary Hoffart nor his worker assembled Ms. Juneau’s furniture once it was moved to her residence. Despite not fully performing under the contract, Gary Hoffart attempted to solicit a greater payment from Ms. Juneau. Ms. Juneau paid Respondent \$250.00 with a check that Gary Hoffart cashed. After cashing the check, Respondent retained the proceeds.

18. It is also known that Respondent solicited business from at least twenty-five other North Dakota consumers, taking their payments by credit card or check. Gary Hoffart processed the credit card payments and cashed checks received from consumers. Because Respondent has failed to respond to the Attorney General’s Civil Investigative Demand (see paragraphs 26 – 27 below), the Attorney General has not identified these twenty-five consumers and has not yet been able to contact them. The Attorney General believes that Respondent either did not perform work for these consumers at all, or did not provide the services he advertised or contracted to perform.

19. Based on a consumer complaint filed with the Attorney General and other information received, it appeared to the Attorney General that Respondent engaged in violations of North Dakota law, and the Attorney General commenced an investigation into Respondent's business practices.

20. Throughout 2016 and into 2017, Respondent has been placing advertisements on Craigslist for the businesses Great Plains Moving & Logistics LLC, Integrity Movers, and IDIS Inc. that contain untrue, deceptive, or misleading assertions or representations.

21. In one version of his advertisements, Respondent includes images of vehicles that Respondent does not own or have available. Defendant further represents that he has "up to 22 men and women" available and that he is licensed, bonded, and insured. All of these representations are false. Exhibit 1, p. 1.

22. In other versions of his advertisements, Respondent makes similar false representations, including that he is licensed, bonded, and insured, and that he has "up to 23 men" available who have "over 25 years experience [sic]." Exhibit 1, p. 2 – 3.

23. In more versions, Respondent advertises moving services offered by members of the armed forces though Defendant is not affiliated with the military and does not employ members of the military. Exhibit 1, p. 4 – 5.

24. In additional versions of his advertisements, Respondent falsely represents that Great Plains Moving & Logistics, Integrity Movers, or IDIS are corporate entities by including the designations "Inc" or "LLC" when Great Plains Moving & Logistics, Integrity Movers, and IDIS are not corporate entities or limited liability

companies. His advertisements may also falsely represent a partnership with U-Haul and/or Penske Truck Rental. Exhibit 1, p. 6 – 8.

25. Respondent previously used the telephone number 701-715-0116 to communicate with consumers in North Dakota and lists that same number on most of his advertisements. This number is associated with a prepaid Verizon telephone that Respondent uses under the name “Bill Peterson.”

26. On November 4, 2016, the Attorney General issued a Civil Investigative Demand (“CID”) to Respondent pursuant to the Attorney General’s authority under N.D.C.C. § 51-15-04. The CID was sent to Respondent at his last known address at the time: 3825 9<sup>th</sup> Ave. S., Fargo, ND 58103. The CID requested response by November 18, 2016. Because Respondent was no longer at that address, the Civil Investigative Demand was returned as undeliverable.

27. On December 7, 2016, the Attorney General sent Respondent a letter requesting that Respondent comply with the Civil Investigative Demand on or before December 16, 2016. This letter was mailed to Respondent at 910 Laverne Dr., Green Bay, WI, 54311, where the Attorney General had been advised the Respondent was staying. This letter was not returned. Respondent never responded to the Civil Investigative Demand. Pursuant to N.D.C.C. § 51-15-07, the Attorney General may issue a cease and desist order for Respondent’s failure to respond to the Civil Investigative Demand.

28. On December 29, 2016, the Attorney General filed an enforcement action in Cass County District Court in order to enjoin Respondent from further violations of N.D.C.C. chs. 51-12 and 51-15. Subsequent to this filing, the Attorney General learned



that Respondent has continued to place advertisements on Craigslist. Exhibit 2. Respondent continues to make the assertions described above and now provides the telephone number 218-443-3817 in his advertisements.

29. It appears to the Attorney General that Respondent, or Respondent's agents on Respondent's behalf, is engaged in in violations of N.D.C.C. ch. 51-12 by offering services to North Dakota consumers using advertisements containing untrue, deceptive, or misleading representations. Further, it appears that Respondent has engaged in violations of ch. 51-15 by making untrue, deceptive, and misleading representations, or engaged in deceptive acts and practices with the intent that others rely thereon.

## ORDER

Based upon the foregoing information, it appears to the Attorney General that Respondent has engaged in violations of N.D.C.C. chs. 51-12 and 51-15 and Respondent has failed or refused to respond to the Civil Investigative Demand as required by N.D.C.C. § 51-15-04; **NOW, THEREFORE, IT IS ORDERED** pursuant to N.D.C.C. § 51-15-07 that Respondent, individually, immediately **CEASE AND DESIST** from: 1) soliciting or selling services and/or merchandise as defined in N.D.C.C. § 51-15-01(3), including moving services, to North Dakota consumers; 2) making, publishing, disseminating, circulating, broadcasting, or placing before the public, or directly or indirectly causing to be made, published, disseminated, circulated, broadcasted, or placed before the public in a newspaper, or other publication, or in the form of a book, notice, handbill, poster, bill, circular, pamphlet, tab, label, letter, television, or radio broadcast, placement on the internet, or in any other way, an advertisement or webpage that contains assertions, representations, or statements of fact that are untrue, deceptive, or misleading in violation of N.D.C.C. § 51-12-01; and 3) soliciting consumers using untrue, deceptive or misleading representations or engaging in deceptive acts or practices, fraud, false pretenses, false promises or misrepresentations with the intent that consumers rely thereon, in violation of N.D.C.C. § 51-15-02. Respondent also shall immediately **CEASE AND DESIST** from issuing any invoices or bills to North Dakota consumers for any services or merchandise and **CEASE AND DESIST** from taking any payments from North Dakota consumers including, but not limited to, direct debits or withdrawals from North Dakota consumers'

bank accounts, cash, checks, or credit card payments for the sale of merchandise as defined in N.D.C.C. § 51-15-01(3).

**YOU ARE NOTIFIED** that pursuant to N.D.C.C. § 12.1-09-03 a person is guilty of a criminal offense if he or she intentionally "alters, destroys, mutilates, conceals, or removes a record, document, or thing with intent to impair its verity or availability" in an official proceeding. As such, intentional destruction of any documents related to this matter may result in criminal prosecution.

#### **NOTICE OF CIVIL PENALTIES**

**YOU ARE FURTHER NOTIFIED** that pursuant to N.D.C.C. § 51-15-07 any violation of this Cease and Desist Order is subject to civil penalties not to exceed \$1,000.00 per violation. Any violation of this Order that also is a violation of N.D.C.C. ch. 51-15 may result in additional civil penalties of not more than \$5,000.00 per violation. Such penalties are separate and in addition to any civil penalties, costs, expenses, investigation fees, and attorney fees pursuant to N.D.C.C. ch. 51-15 or any other applicable statute. Nothing in this Order is intended to limit or waive any rights and remedies available to the State of North Dakota or consumers.

**NOTICE OF RIGHT TO REQUEST HEARING**


**YOU ARE NOTIFIED** that pursuant to N.D.C.C. § 51-15-07 you may request a hearing before the Attorney General if such a request is made in writing WITHIN TEN (10) DAYS AFTER THE RECEIPT OF THIS ORDER. Respondent has the right to be represented by legal counsel at the hearing at the Respondent's expense.
