### Purpose of this Notice

Title V of the Gramm-Leach-Bliley Act (GLBA) generally prohibits any financial institution, directly or through its affiliates, from sharing nonpublic personal information about you with a nonaffiliated third party unless the institution provides you with a notice of its privacy policies and practices, such as the type of information that it collect about you and the categories of persons or entities to whom it may be disclosed. #### 1. Information we collect:

We collect nonpublic personal information about you from the following sources:

## 2. Information we may disclose to third parties:

We may disclose the following kinds of nonpublic personal information about you:

- Information about your transactions with us, our affiliates such as your policy coverage, premium, and payment information

We do not disclose any nonpublic personal information about or clients or former clients to anyone, except as permitted by law.





# 3. Affiliates with whom we share certain information protected by the Fair Credit Reporting Act, unless you tell us not to:

Unless you tell us not to, we may share with our affiliated companies information about you, including:

Information we obtain from your insurance application, such as your name, address, social security number (or EIN), Date of Hire, Date of Birth, Dependent information, policy information

Our affiliated companies who may receive this information are:

- Insurance Agencies such as Group Access Inc.
- Insurance Carriers
- Third Party Administrators such as BASIC & Admin America (if enrolled in products)
- Payroll Vendors (if applicable)
