OPENING

1. Opening of the meeting, general information and approval of the draft agenda

The Chairperson of the Administrative Council (AC Chair), Mr. Sobrino Mate, declared the agenda adopted as proposed.

4. Adoption of the policy on plant material submitted for DUS testing (DOC-AC-2024-1-04)

The members of the Administrative Council adopted the updated policy on plant material submitted for DUS testing.

5. Entrustment of Examination Offices (DOC-AC-2024-1-05)

The members of the Administrative Council adopted the 3 recommendations put forward by the Audit Team Leader for The Netherlands (Naktuinbouw), Poland (Centralny Osrodek Badania Odmiam Roslin Uprawnych (COBORU) and Croatian Agency for Agriculture and Food (HAPIH). The Netherlands abstained on the first vote; Poland abstained on the second vote; Croatia abstained on the third vote.

AC Decisions on the adoption of CPVO Technical Protocols (DOC-AC-2024-1-06)

The members of the Administrative Council unanimously adopted the New Technical Protocol: CPVO-TP/248/1 *Panicum miliaceum* L. and the Revision of existing Technical Protocols: CPVO-TP/045/2-Rev.3 *Brassica oleracea* L. convar. *botrytis* (L.) Alef. var. *botrytis* L.; CPVO-TP/048/3-Rev.3 *Brassica oleracea* L. var. *capitata* L.; CPVO-TP/054/2-Rev.2 *Brassica oleracea* L. var. *gemmifera* Zenker; CPVO-TP/065/2-Rev *Brassica oleracea* L. var. *gongylodes* L. (*Brassica oleracea* Kohlrabi Group); CPVO-TP/151/2-Rev.3 *Brassica oleracea* L. var. *italica* Plenck.

7. Adoption by analogy of Commission Decision C(2024) 1038 of 21 February 2024 on the transfer of pension rights (DOC-AC-2024-1-07)

The members of the Administrative Council unanimously adopted the decision on the transfer of pension rights by analogy.

The AC members did not adopt the amended "AC decision on eligibility criteria for observership in its meeting of non-governmental organisations and procedural rules".

The proposal to admit the International Association for the Protection of Intellectual Property (AIPPI) was withdrawn due to the refusal of the amendments concerning the rules on observer status before the Administrative Council.
