Subject: Notification of Hazardous Substance Liability on ANCSA-conveyed Contaminated Sites

Dear Ms. Taylor,

The purpose of this letter is to request the completion of the inventory and cleanup plans for contaminated sites located on lands conveyed by the Bureau of Land Management (BLM) to Alaska Native Corporations under the Alaska Native Claims Settlement Act (ANCSA). Although some of the hundreds of sites on ANCSA lands have been cleaned up, many have not, and pose a continuing risk to human health and the environment.

ANCSA site lists, compiled by BLM, are provided for your reference in Appendix A. However, the inventory is neither complete nor comprehensive, despite the fact that since 1990 Congress has repeatedly directed the Department of Interior to report on contamination existing on ANCSA-conveyed lands prior to their conveyance to Alaska Native Corporations. The Alaska Department of Environmental Conservation (DEC) has worked along with BLM and other federal agencies to continue to refine the inventory; however, it is clear that further resources are needed to complete the inventory, verify whether contamination exists at some sites, and complete cleanup at those sites not currently being actively cleaned up.

Both Alaska Statute (AS) Title 46 and the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) establish that BLM is a responsible party at the sites listed on Appendix A and liable for any release of hazardous substance on lands subsequently conveyed to Alaska Native Corporations. Liability is joint and several under both of these laws. BLM is liable because it was an owner of the property at the time of a release either prior to or during conveyance. Note that a "release" includes, at a minimum, passive migration of hazardous substances in the environment. As a responsible party for the ANCSA-conveyed contaminated sites, BLM is liable for their investigation, cleanup, and the payment of State costs. DEC requires, within two months of the date of this letter, that BLM perform the following actions:

- 1) provide to DEC an update on the cleanup status for sites on the BLM ANCSA Inventory¹ in the “In a Cleanup Program” and “Orphan” status, see Appendix A;
- 2) for those sites in Appendix A where no site characterization or delineation of the nature and extent of contamination has been initiated, or where cleanup has been initiated but is not complete and no active cleanup progress has been conducted in the last year, submit a plan of action to DEC to complete the cleanup; and
- 3) complete the ANCSA Inventory.

Please note that AS 46.04.010 (Reimbursement for Cleanup Expenses) and 46.08.070 (Reimbursement for Containment and Cleanup) require that DEC seek recovery of certain costs, including oversight activities, incurred by the State in responding to the release or threatened release of hazardous substances. Billable staff time includes all time spent on activities related to the incident, including site inspections, response and report reviews, correspondence, telephone conversations, meetings, and legal services. Billable oversight expenditures also include indirect State overhead costs and could include travel and contractual costs. In addition to our authority under Alaska Statutes, CERCLA allows states to recover response costs related to cleanup of contaminated sites under 42. U.S.C. 9607(a)(4).

I thank you for your attention to this matter and look forward to the day when all these sites have been cleaned up and Alaska Native Corporations will be able to use their lands freely.
