**Change Existing Address Entrance Requirements**

<b>Authority:</b>	Revised Municipal Code, Chapter 49, Article IV
<b>Purpose:</b>	The City Engineer or designee has the authority to assign addresses within the boundaries of the City & County of Denver per Sec. 49-56 (Code 1950 341.2) of the Denver Revised Municipal Code (DRMC) and per the Engineering Addressing Policy dated 02/01/2010.
<b>Document Date:</b>	01/01/2024
<b>Address Date:</b>	Addresses issued are in effect until: <ul style="list-style-type: none"> <li>• The owner requests a change of address</li> <li>• For safety and sound practice</li> </ul>
<b>Request:</b>	The request to change an existing address when the structure remains may be requested for various reasons, but not limited to: <ul style="list-style-type: none"> <li>• Safety</li> <li>• Prior to logging in for permits, or permit requirement</li> <li>• Change in main entrance due to modifications to the existing structure</li> </ul>

<b>Considerations:</b>	All requests are handled in the order they are received.

<b>Submittal Requirements:</b>	<b>Change existing address:</b> Applicant can provide a site plan and/or plot plan, a bird-eye view image of the property, or pictures of the property. All plans shall include the north arrow, surrounding street designations and location of the structure with respect to the property lines. Mark the front door with an 'X' to indicate the entrance. Additional information may be required.
<b>Fees:</b>	\$60 per address and/or \$60 per unit. Upon change of ownership of an incorrectly out-of-sequence addressed property the City shall be notified to correct the address for safety reasons. This change shall be free of charge.
