MORNING SESSION #1

8:47am: CONVENE with roll call.

Board members present: C. Freeman, P. McCarthy, M. Darrow, S. Adamczak, T. Homza, and J., Jones. Board member G. Wilson was not present.

Motion to approve current agenda passed.
