This shows the FY25 starting budget, the status of FY24 budget closeout, and actuals for FY23. In FY24, the agency lapsed funds (~\$108,000) with another ~\$20,000 in uncollected program receipts. The lapsed funds are primarily due to extended personnel vacancies. The FY25 budget (attached) shows a slight increase (~\$20,000) to account for annual personnel cost increases.

**Personnel:** FY25 has nine budgeted full-time staff positions. Currently only seven are filled. Both of our admin positions are vacant - the LOA2 position since December. Recruitment efforts to fill both positions are ongoing. Postings have only seen on average 1-2 viable applicants that meet the minimum qualifications. It is an applicant's market so-to-speak, and there have been several times that an applicant has withdrawn interest after accepting another position within state service before we have been able to offer the position.

**Travel:** Travel should cover all costs for Commissioner travel for FY25 in-person meetings and travel for one person, either a Commissioner or staff, to the annual COGEL conference.

The conference will be held in Los Angeles, December 8 - 11, 2024. Early registration pricing is available until October 31. I cannot recommend this conference enough. The conference is wholly focused on topics that are distinctly relevant to APOC's work and provides in-depth coverage of trending issues, changes in legal landscapes, and networking opportunities. Please let me know if any Commissioner wishes to attend this year.

Contractual: Includes general contractual fees, overhead costs and chargebacks for centralized services provided by the Department of Administration. This is an area we have little control over. DOA is aware that our current appropriation likely will not cover FY25 costs. With ongoing vacancies, we have been able to move funds from the personnel line to cover deficits, but should the agency be fully staffed, it may be necessary to seek a supplemental appropriation. Looking forward to FY26, we have already begun work with administrative services to address the anticipated shortfall.
