#### **Other Relevant Dates for the 2012 State Primary Election:**

**Friday, July 27, 2012** (33 days prior to the date of the Primary Election)

The last day that a candidate may give or loan their campaign more than \$5000.

**Friday, October 12, 2012,** (45 days after the date of the Primary Election)

The last day a candidate may accept contributions.

**Monday, November 26, 2012** (90 days after the date of the Primary Election)

The date by which candidates must distribute the amount held in their campaign account.

#### **Other Relevant Dates for the 2012 State General Election:**

**Friday, October 5, 2012** (33 days prior to the date of the General Election)

The last day that a candidate may give or loan their campaign more than \$5000.

**Friday, December 21, 2012** (45 days after the date of the General Election)

The last day a candidate may accept contributions.

**Friday February 1, 2013**

The date by which candidates must distribute the amount held in their campaign account.

\*During the 9 days before an election, you must report the contributor name and amount of all monetary and non-monetary contributions over \$250 to APOC within 24 hours of the time you receive each contribution. You may need to report each day during that period, or not at all. You must fax, email, hand-carry, or if after hours, phone in the report. **Do not mail 24 Hour Reports!!**
