SUBJECT: GROUP 3(d)

1. AS AGREED BY THE TRADE NEGOTIATIONS COMMITTEE ON 17-18 JULY 1974, A MEETING OF THE GROUP, ESTABLISHED IN ACCORDANCE WITH THE LAYOUT OF PARAGRAPH 3(d) OF THE TOKYO DECLARATION, WILL BE CONVENED TO CARRY OUT TECHNICAL AND ANALYTICAL WORK ON THE MULTILATERAL SAFEGUARD SYSTEM. THE MEETING WILL BEGIN AT 10 A.M. ON THURSDAY, 17 OCTOBER 1974, AND WILL BE HELD IN THE PALAIS DES NATIONS.

2. RELEVANT DOCUMENTS FOR THE WORK OF THE GROUP ARE:

- (a) FACTUAL NOTE BY THE SECRETARIAT ON SAFEGUARDS (DOCUMENT MTN/3D/1);
- (b) FACTUAL NOTE BY THE SECRETARIAT ON SAFEGUARDS FOR MAINTENANCE OF ACCESS (DOCUMENT MTN/3D/2);
- (c) REPORT ON STATUS OF WORK BY THE COMMITTEE ON TRADE IN INDUSTRIAL PRODUCTS (DOCUMENT L/3886, PARAGRAPHS 70-82);
- (d) STATEMENTS BY THE BRAZILIAN AND THE NIGERIAN REPRESENTATIVES ON SAFEGUARDS AT THE TWENTI-FIFTH SESSION OF THE COMMITTEE ON TRADE AND DEVELOPMENT (DOCUMENTS COM.TD/91 AND 92);
- (e) NOTES BY THE UNCTAD SECRETARIAT ON SAFEGUARDS AND STANDSTILL, SUBMITTED TO THE COMMITTEE ON MANUFACTURES AT ITS SIXTH SESSION (DOCUMENTS TD/B/C.2/R.4 AND SUPP.1);
- (f) DRAFT RESOLUTION SUBMITTED BY PAKISTAN ON BEHALF OF THE GROUP OF 77 ON SAFEGUARDS AND STANDSTILL, SUBMITTED TO THE COMMITTEE ON MANUFACTURES AT ITS SIXTH SESSION (DOCUMENT TD/B/C.2/L.71).

3. THE MEETING IS OPEN TO THOSE COUNTRIES WHICH HAVE INDICATED THEIR DECISION TO PARTICIPATE IN THE MULTILATERAL TRADE NEGOTIATIONS AND HAVE THUS ASSUMED MEMBERSHIP OF THE TRADE NEGOTIATIONS COMMITTEE. SUCH MEMBERS ARE ACCORDINGLY INVITED TO INFORM ME AS SOON AS POSSIBLE OF THE NAMES OF THEIR REPRESENTATIVES WHO WILL ATTEND THE MEETING OF THE GROUP.

4. REPRESENTATIVES NOT HAVING YET REGISTERED FOR THE MULTILATERAL TRADE NEGOTIATIONS ARE REQUESTED TO REGISTER WITH THE CONFERENCE OFFICER, VILLA LE BOCAE, AS SOON AS POSSIBLE, TO OBTAIN THE NECESSARY ENTRANCE CARDS.
