SUBJECT: INTERSESSIONAL COMMITTEE - PROGRAMME OF MEETINGS FOR AUGUST AND SEPTEMBER 1957

WHEN THE INTERSESSIONAL COMMITTEE AT ITS MEETING ON 24 - 27 APRIL (IC/SR.30) DISCUSSED THE PROCEDURES TO BE FOLLOWED BY THE CONTRACTING PARTIES IN THEIR EXAMINATION OF THE TREATY ESTABLISHING THE EUROPEAN ECONOMIC COMMUNITY IT WAS AGREED THAT THE COMMITTEE WOULD MEET AGAIN IN THE LATTER PART OF AUGUST.

THE TIMING OF THE PROPOSED MEETING IN AUGUST WAS CONTINGENT UPON THE ARRANGEMENTS FOR THE SUBMISSION OF QUESTIONS TO THE INTERIM COMMITTEE FOR THE COMMON MARKET CONCHENING THE PROVISIONS OF THE TREATY AND TESEP IMPLEMENTATION AND UPON THE RECEIPT OF THE ANSWERS FROM THE INTERIM COMMITTEE, CONTRACTING PARTIES WERE ASKED TO SUBMIT QUESTIONS TO ME BY 31 MAY, MOST OF THE QUESTIONS WERE NOT RECEIVED UNTIL THE PIRST WEEK OF JUNE AND THE TASK OF PREPARING THE CONSCLIDATED QUESTIONS (1/639) WAS NOT COMPLETED WITHOUT WITHOUT THE UNTERIM COMMITTEE WAS ASKED TO SUPPLY EXPLANATIONS IN ANSWER TO THE CHISTICAL IN VIEW OF THIS DELAY, THE LENGTH OF THE CHAIRMAN OF THE COMPLETE THAT.

IN VIEW OF THIS DELAY, THE LENGTH OF THE QUESTIONSAIRE AND THE COMPLETTY OF THE ISSUES INVOLVED, IT WILL NOT BE POSSIBLE FOR HIM TO SUBMIT THE ANSWERS TO THE QUESTIONS BEFORE THE HEGINNING OF AUGUST. IT APPEARS UNLIKELY THEREFORE THAT THE SECRETARIAT WILL BE ABLE TO ISSUE THE REPLIES IN A GATT DOCUMENT IN BOTH WORKING LANGUAGES HEFORE THE MIDDLE OF AUGUST.

SINCE GOVERNMENTS WILL WISH TO HAVE AMPLE TIME TO STUDY THE REPLIES TO
THE CHESTICAL HEFORE RESUMING THEIR DISCUSSIONS I PROPOSE TRAT THE AUGUST
MEETING BE POSTPONED AND BE COMBINED WITH THE NEXT STATUTORY MEETING OF THE
COMMITTEE TO BE HELD THREE WEEKS PRIOR TO THE OFFERING OF THE SESSION, I
PROPOSED IN GATT/AIR/113 THAT THAT MEETING OF THE COMMITTEE SHOULD BEQIN AT
3 P.M. ON 23 SEPTEMBER.
