SUBJECT: NON-TARIFF MEASURES SUB-GROUP "QUANTITATIVE RESTRICTIONS"

AT ITS MEETING OF MARCH 1976, THE SUB-GROUP "QUANTITATIVE RESTRICTIONS" DEALING WITH QUESTIONS OF IMPORT LICENSING PROCEDURES INVITED DELEGATIONS TO SUBMIT IN WRITING TO THE SECRETARIAT, IN TIME FOR THE NEXT MEETING, ANY NEW OR ADDITIONAL PROPOSALS AND COMMENTS ON THE TWO DRAFT TEXTS REPRODUCED AT PAGES 15-19 OF DOCUMENT MTN/NTM/W/2 AND ON THE PROPOSALS ALREADY RECEIVED AND REPRODUCED IN MTN/NTM/W/11 AND ADDENDA (MTN/NTM/14 PARAGRAPH 13).
2. ACCORDINGLY, ALL INTERESTED COUNTRIES PARTICIPATING IN THE MULTILATERAL TRADE NEGOTIATIONS ARE INVITED TO SUBMIT ANY NEW OR ADDITIONAL PROPOSALS AND COMMENTS TO THE SECRETARIAT AS SOON AS POSSIBLE.
