SUBJECT: GROUP "AGRICULTURE" - SUB-GROUP ON DAIRY PRODUCTS

- 1. AS IT AGREED IN FEBRUARY LAST (MTN/DP/3, PARAGRAPH 6), THE SUB-GROUP ON DAIRY PRODUCTS WILL CONVENE ON 12 JULY 1976. THE MEETING WILL START AT 3 P.M. AT THE PALAIS DES NATIONS.
- 2. THE SUB-GROUP AGREED TO CONTINUE ITS CONSIDERATION OF VARIOUS ELEMENTS CONTAINED IN THE PROPOSALS CONCERNING THE CATEGORIES OF QUESTIONS AGREED ON AT ITS FIRST MEETING (MTN/DP/1, PARAGRAPH 6) AND TO DEAL WITH AND EXAMINE IN A SYSTEMATIC AND ORDERLY WAY ANY PROPOSALS WHICH HAVE BEEN OR MICHT BE MADE. IN THIS RESPECT A SUGGESTION WAS PUT FORWARD (MTN/DP/W/20) WHICH THE SUB-GROUP ALSO AGREED TO DISCUSS AT ITS NEXT MEETING (MTN/DP/3, PARAGRAPH 4).
- 3. THE SUB-GROUP LIKEWISE AGREED THAT IT WOULD BE OPEN TO IT TO REVERT TO THE ANALYSIS DESCRIBED IN PARAGRAPH 4 OF DOCUMENT MIN/DP/1. DELEGATIONS WHICH HAVE NOT YET PRESENTED THE MEASURES THEY MAINTAIN IN THE DAIRY FRODUCTS SECTOR ARE INVITED TO DO SO AT THE EARLIEST OPPORTUNITY (MTN/DP/3, PARAGRAPH 3). IT WAS AGREED FURTHERMORE THAT THE SECRETARIAT'S SUMMARY OF EXPORT AND IMPORT MEASURES (MTN/DP/W/9) WOULD BE REVISED, AND DELEGATIONS ARE INVITED TO SUBMIT AS SOON AS POSSIBLE INFORMATION AND COMMENTS SO THAT THE SUMMARY MAY BE COMPLETED AND UP-DATED.
- 4. A PROPOSAL CONCERNING FUTURE WORK HAS BEEN RECEIVED AND HAS BEEN CIRCULATED IN DOCUMENT MTN/DP/W/21; IN PARTICULAR IT CONTAINS SUGGESTIONS CONCERNING DOCUMENTATION THAT MIGHT BE FURNISHED BY MEMBERS OF THE SUB-CROUP WITH A VIEW TO WORK AT ITS FORTHCOMING MEETING.
- 5. THE MEETING IS OPEN TO THOSE COUNTRIES WHICH HAVE INDICATED THEIR DECISION TO PARTICIPATE IN THE MULTILATERAL TRADE NEGOTIATIONS AND HAVE THUS ASSUMED MEMBER-SHIP OF THE TRADE NEGOTIATIONS COMMITTEE. SUCH MEMBERS ARE ACCORDINGLY INVITED TO INFORM ME AS SOON AS POSSIBLE OF THE NAMES OF THEIR REPRESENTATIVES WHO WILL ATTEND THE MEETING OF THE SUB-GROUP.
- 6. REPRESENTATIVES NOT HAVING YET REGISTERED FOR THE MULTILATERAL TRADE NEGOTIATIONS ARE REQUESTED TO REGISTER WITH THE CONFERENCE OFFICER, VILLA LE BOCAGE, AS SOON AS POSSIBLE, TO OBTAIN THE NECESSARY ENTRANCE CARDS.
