SUBJECT: MEETING OF INTERSESSIONAL COMMITTEE ON 9 JULY 1958 REQUEST BY AUSTRALIA FOR RENEGOTIATION UNDER ARTICLE XXVIII: 4

THE FOLLOWING COMMUNICATION HAS BEEN RECEIVED FROM THE GOVERNMENT OF AUSTRALIA:

"I REFER TO YOUR GATT AIRGRAM NO. 132 OF THE 19TH JUNE INDICATING THAT THERE WILL BE A MEETING OF THE INTERSESSIONAL COMMITTEE ON THE 9TH JULY. IN ACCORDANCE WITH PARAGRAPH 3 OF YOUR AIRGRAM THE AUSTRALIAN GOVERNMENT WOULD LIKE TO HAVE INCLUDED ON THE AGENDA FOR THE MEETING ON THE 9TH JULY CONSIDERATION OF AN AUSTRALIAN REQUEST FOR AUTHORITY UNDER ARTIGIE XXVIII. PARAGRAPH 4 TO RENEGOTIATE THE FOLLOWING TARIFF ITEMS IN PART II, PREFERENTIAL TARIFF. SCHEDULE I:-

> TARIFF ITEMS 392(A)(2)(a), 392(A)(2)(b), 392(A)(4), 392(A)(5)(a) and (b).

"THIS REQUEST STEMS FROM A REPORT OF THE TARIFF BOARD ON COTTON YARNS. THE EFFECT OF THE BOARD'S RECOMMENDATION IS:-

- (a) TO DELETE THREE BY-LAW ITEMS FROM THE TARIFF AND TO INSERT INSTEAD ONE BY-LAW ITEM CARRYING LOWER RATES OF DUTY:
- (b) TO VARY THE RATES OF DUTY ON ITEMS 392(A)(5)(a) AND (b) WHICH ARE PROTECTIVE ITEMS FOR COTTON YARNS COARSER (i.e., LESS) THAN NO. 50 COUNT. IN OVERFILL TERMS. THE REVISION OF THE COTTON YARN DUTIES MEANS INCREASED DUTIES ON SOME TYPES, LOWER DUTIES ON OTHER TYPES AND RETENTION OF EXISTING DUTIES ON OTHERS. THE GOVERNMENT BELIEVES ITS BEST COURSE IS TO RENEGOTIATE DUTIES ON COTTON YARNS CENERALLY. THE CONCESSIONS NEGOTIATED IN PART I OF SCHEDULE I ARE NOT AFFECTED AND WILL REMAIN IN FORCE.

"THE AUSTRALIAN GOVERNMENT WOULD AIM TO BRING THE NEGOTIATIONS TO A CONCLUSION ON THE BASIS SET OUT IN PARAGRAPH 2 OF ARTICLE XXVIII. CONSIDER TION OF THIS MATTER IS REQUESTED AT THE INTERSESSIONAL COMMITTEE MEETING ON THE 9TH JULY WITHOUT F.IL SO THAT NEGOTIATIONS MAY BE CON-CLUDED IN TIME FOR THE PURLY INTRODUCTION OF NEW DUTIES."
