OBJET: GROUPE "AGRICULTURE" - SOUS-GROUPE DES PRODUITS LAITIERS

1. CONFORMEMENT A LA RECOMMANDATION FORMULEE PAR LE GROUPE "AGRICULTURE" DANS LA DECISION ADOPTEE LORS DE SA REUNION DE JUILLET (MTN/AG/7, ANNEXE, PARAGRAPHE 6) ET APRES CONSULTATION DES DELEGATIONS, LE SOUS-GROUPE DES PRODUITS LAITIERS SE REUNIRA LE MARDI 11 OCTOBRE 1977 A 10H.30. LA REUNION SE TIENDRA AU CENTRE WILLIAM RAPPARD.

PEUVENT PARTICIPER A CETTE REUNION LES PAYS QUI ONT FAIT CONNAITRE LEUR DECISION DE PARTICIPER AUX NEGOCIATIONS COMMERCIALES MULTILATERALES, DEVENANT AINSI MEMBRES DU COMITE DES NEGOCIATIONS COMMERCIALES. EN CONSEQUENCE, CES MEMBRES SONT INVITES A ME COMMUNIQUER LE PLUS TOT POSSIBLE LES NOMS DE LEURS REPRESENTANTS A LA REUNION DU SOUS-GROUPE.

SUBJECT: GROUP "AGRICULTURE" - SUB-GROUP ON DAIRY PRODUCTS

1. IN ACCORDANCE WITH THE RECOMMENDATION MADE BY GROUP "AGRICULTURE" IN THE DECISION ADOPTED AT ITS JULY MEETING (MTN/AG/7, ANNEX, PARAGRAPH 6) AND FOLLOWING CONSULTATIONS WITH DELEGATIONS, THE SUB-GROUP ON DAIRY PRODUCTS WILL CONVENE ON TUESDAY, 11 OCTOBER 1977 AT 10.30 A.M. THE MEETING WILL BE HELD AT THE CENTRE WILLIAM RAPPARD.

THE MEETING IS OPEN TO THOSE COUNTRIES WHICH HAVE INDICATED THEIR DECISION TO PARTICIPATE IN THE MULTILATERAL TRADE NEGOTIATIONS AND HAVE THUS ASSUMED MEMBERSHIP OF THE TRADE NEGOTIATIONS COMMITTEE. SUCH MEMBERS ARE ACCORDINGLY INVITED TO INFORM ME AS SOON AS POSSIBLE OF THE NAMES OF THEIR REPRESENTATIVES WHO WILL ATTEND THE MEETING OF THE SUB-GROUP.
