SUBJECT: NON-TARIFF MEASURES SUB-GROUP "TECHNICAL BARRIERS TO TRADE"

1. THE SUB-GROUP WILL RECONVENE AT 3 P.M. ON WEDNESDAY, 18 OCTOBER 1978 IN THE CENTRE WILLIAM RAPPARD.

2. AT THE REQUEST OF A NUMBER OF DELEGATIONS, A NEW DOCUMENT CONTAINING A PROPOSED REVISION OF THE TEXT OF THE DRAFT STANDARDS CODE (MTN/NTM/W/192 AND ADD.1) WILL BE CIRCULATED BY THE TIME THAT THE SUB-GROUP MEETS. THE OTHER MAIN DOCUMENTS, WHICH HAVE BEEN BEFORE THE SUB-GROUP FOR SOME TIME, ARE:
