SUBJECT: NON-TARIFF MEASURES SUB-GROUP "SUBSIDIES AND COUNTERVAILING DUTIES"

1. THE SUB-GROUP "SUBSIDIES AND COUNTERVAILING DUTIES" WILL RECONVENE AT 3 P.M. ON THURSDAY, 14 DECEMBER 1978. THE MEETING WILL BE HELD IN THE CENTRE WILLIAM RAPPARD.

2. IT IS PROPOSED THAT THE SUB-GROUP PROCEED WITH NEGOTIATIONS ON AN ARRANGEMENT ON SUBSIDIES AND COUNTERVAILING DUTIES ON THE BASIS OF DOCUMENTS MTN/NTM/W/68, MTN/INF/18, MTN/NTM/W/164 AND CORR.1, MTN/37, MTN/NTM/W/201 AND ANY OTHER DOCUMENTATION THAT MIGHT BE CIRCULATED PRIOR TO THE MEETING.

3. THE MEETING IS OPEN TO THOSE COUNTRIES WHICH HAVE INDICATED THEIR DECISION TO PARTICIPATE IN THE MULTILATERAL TRADE NEGOTIATIONS AND HAVE THUS ASSUMED MEMBERSHIP OF THE TRADE NEGOTIATIONS COMMITTEE. SUCH MEMBERS ARE ACCORDINGLY INVITED TO INFORM ME AS SOON AS POSSIBLE OF THE NAMES OF THEIR REPRESENTATIVES WHO WILL ATTEND THE MEETING OF THE SUB-GROUP.

PEUVENT PARTICIPER A CETTE REUNION LES PAYS QUI ONT FAIT CONNAITRE LEUR DECISION DE PARTICIPER AUX NEGOCIATIONS COMMERCIALES MULTILATERALES, DEVENANT AINSI MEMBRES DU COMITE DES NEGOCIATIONS COMMERCIALES. EN CONSEQUENCE, CES MEMBRES SONT INVITES A ME COMMUNIQUER LE PLUS TOT POSSIBLE LES NOMS DE LEURS REPRESENTANTS A CETTE REUNION DU SOUS-GROUPE.
