1. THE PANEL ON SUBSIDIES AND STATE-TRADING WILL MEET IN THE PALAIS DES NATIONS FROM 6-10 APRIL COMMENCING AT 3 P.M. ON MONDAY 6 APRIL. THE TERMS OF REFERENCE FOR THE PANEL ARE SET OUT IN DOCUMENT L/925. THE PANEL WILL ELECT A CHAIRMAN. THE FOLLOWING CHANGES HAVE BEEN MADE IN THE MEMBERSHIP OF THE PANEL:

2. THE EXPERT GROUP ON ANTI-DUMPING AND COUNTERVAILING DUTIES WILL MEET IN THE PALAIS DES NATIONS FROM 13-17 APRIL COMMENCING AT 3 P.M. ON MONDAY 13 APRIL. THE TERMS OF REFERENCE FOR THE GROUP ARE SET OUT IN DOCUMENT L/908. THE CHAIRMAN OF THE CONTRACTING PARTIES HAS APPOINTED MR. V. POCHÉLU (FRANCE) AS CHAIRMAN OF THE GROUP. THE EXECUTIVE SECRETARY, IN CONSULTATION WITH GOVERNMENTS, HAS INVITED THE FOLLOWING EXPERTS TO SERVE AS MEMBERS OF THE GROUP:
