SUBJECT: GROUP OF EXPERTS ON TEMPORARY DUTY-FREE IMPORTATION OF  
PACKING MATERIALS AND CERTAIN PROFESSIONAL EQUIPMENT

IN ADOPTING THE PROGRAMME OF MEETINGS FOR 1960 THE CONTRACTING PARTIES DECIDED AT THEIR FIFTEENTH SESSION THAT A GROUP OF EXPERTS ON TEMPORARY DUTY-FREE IMPORTATION OF PACKING MATERIALS AND CERTAIN PROFESSIONAL EQUIPMENT SHOULD BE CONVENED. THIS GROUP WILL MEET IN THE PALAIS DES NATIONS, GENEVA, FROM 11-15 JANUARY COMMENCING AT 3 P.M. ON MONDAY 11 JANUARY.

THE TERMS OF REFERENCE FOR THE GROUP AS APPROVED BY THE CONTRACTING PARTIES AT THEIR FIFTEENTH SESSION (SR.15/14) ARE AS FOLLOWS: "TO EXAMINE THE DRAFT CONVENTION ON THE TEMPORARY ADMISSION OF PACKING MATERIALS AND TO CONSIDER THE PROBLEMS INVOLVED IN THE TEMPORARY IMPORTATION OF PROFESSIONAL EQUIPMENT AND OF CINEMA AND TELEVISION EQUIPMENT AND TO MAKE RECOMMENDATIONS TO THE CONTRACTING PARTIES." THE DRAFT CONVENTION TO BE EXAMINED BY THE GROUP IS CONTAINED IN DOCUMENT L/1068.
