SUBJECT: WORKING PARTY ON ITALIAN IMPORT RESTRICTIONS

1. IN ACCORDANCE WITH ARRANGEMENTS MADE BY THE CONTRACTING PARTIES AT THEIR SEVENTEENTH SESSION THE CHAIRMAN HAS APPOINTED A WORKING PARTY TO REVIEW THE ITALIAN IMPORT RESTRICTIONS. THE COMPOSITION OF THE WORKING PARTY IS AS FOLLOWS:

 - (i) TO CONSIDER THE ITALIAN IMPORT RESTRICTIONS WHICH ARE NO LONGER JUSTIFIED FOR BALANCE-OF-PAYMENTS REASONS AND WHICH WERE THE SUBJECT OF CONSULTATIONS UNDER PARAGRAPH 1 OF ARTICLE XII; AND
 - (ii) TO REPORT PROMPTLY THEREON, AS APPROPRIATE, TO THE COUNCIL.
- 3. THE WORKING PARTY WILL MEET FROM 10:30 A.M. ON 27 MARCH 1961.
 MEETINGS OF THE WORKING PARTY, AS AGREED BY THE COUNCIL, WILL BE HELD
 IN ROME (IN SALA DEI CONGRESSI, MINISTERO DEGLI AFFARI ESTERI, PALAZZO
 DELLA FARNESINA; REPRESENTATIVES ARRIVING IN ROME CAN CONTACT THE
 SECRETARIAT IN ROOM 1055 IN THE MINISTRY, TELEPHONE 399156, EXTENSION
 2055).
