SUBJECT: REVIEW OF TRADE RELATIONS BETWEEN YUGOSLAVIA AND CONTRACTING PARTIES SIGNATORIES TO THE DECLARATION OF 25 MAY 1959

1. AT THE MEETING OF THE COUNCIL OF REPRESENTATIVES IN FEBRUARY-MARCH 1961 (C/M/4) IT WAS AGREED THAT, AS AN EXPERIMENT, THE SECOND ANNUAL REVIEW PROVIDED FOR IN SECTION C OF THE DECLARATION ON YUGOSLAVIA WOULD BE CARRIED OUT BY THE COUNCIL AT ITS MEETING IN SEPTEMBER. HOWEVER, AS WAS INDICATED IN THE ADVANCE AGENDA (C/16) FOR THE COUNCIL'S SEPTEMBER MEETING, IT APPEARS THAT ADDITIONAL INFORMATION WOULD BE AVAILABLE IF THE REVIEW WERE HELD AT A LATER DATE AND THE COUNCIL MAY DECIDE, THEREFORE, TO DEFER THE REVIEW UNTIL THE NINETEENTH SESSION.
2. TO FACILITATE THE SECOND REVIEW, I WOULD BE GRATEFUL IF OTHER PARTIES TO THE DECLARATION WOULD SUPPLY INFORMATION ON THE MANNER IN WHICH THEY ARE APPLYING CUSTOMS TARIFFS AND OTHER COMMERCIAL POLICY MEASURES (e.g. QUANTITATIVE IMPORT AND EXPORT RESTRICTIONS) IN THEIR TRADE WITH YUGOSLAVIA. THIS INFORMATION SHOULD REACH THE SECRETARIAT AS SOON AS POSSIBLE AND IN ANY CASE NOT LATER THAN 25 SEPTEMBER 1961.
3. IF THIS INFORMATION HAS ALREADY BEEN SUPPLIED IN RESPONSE TO GATT/AIR/212 OF 14 OCTOBER 1960, WHICH WAS ISSUED IN CONNEXION WITH THE FIRST REVIEW IN NOVEMBER 1960, CONTRACTING PARTIES ARE REQUESTED TO NOTIFY ANY MODIFICATION WHICH MAY HAVE TAKEN PLACE SINCE THEIR LAST NOTIFICATION OR, ALTERNATIVELY, TO CONFIRM THAT NO SUCH MODIFICATION HAS TAKEN PLACE.
