SUBJECT: MEETINGS OF THE COMMITTEE ON BALANCE-OF-PAYMENTS RESTRICTIONS

- 1. IN ACCORDANCE WITH THE CURRENT PROGRAMME OF MEETINGS (L/1745) AND AS INSTRUCTED BY THE COUNCIL (SEE C/M/9, PAGES 9 AND 10), THE COMMITTEE ON BALANCE-OF-PAYMENTS IMPORT RESTRICTIONS WILL MEET FROM 7 MAY TO CARRY OUT CONSULTATIONS UNDER THE RELEVANT PROVISIONS OF ARTICLES XII AND XVIII:B WITH FIVE CONTRACTING PARTIES. THE MEETING WILL COMMENCE AT 3 P.M. ON MONDAY, 7 MAY, AT THE PALAIS DES NATIONS, GENEVA.
- 2. AS INDICATED IN SECTIONS 4 AND 5 OF GATT/AIR/274 THE COMMITTEE WILL HAVE TO RECESS FROM 14 TO 16 MAY, AND WILL RESUME ON 17 MAY TO CONSIDER DRAFT REPORTS ON THE CONSULTATIONS. CONSEQUENTLY IT IS ESSANTIAL THAT ALL THE CONSULTATIONS ARE CONCLUDED BY 12 MAY. IN THE LIGHT OF THIS, THE CHAIRMAN OF THE COMMITTEE HAS FIXED THE COMMENCING DATES FOR THE CONSULTATION AS FOLLOWS:
