SUBJECT: MEETING OF THE COMMITTEE ON BALANCE-OF-PAYMENTS RESTRICTIONS

IN ACCORDANCE WITH THE ARRANGEMENTS FOR CONSULTATIONS IN 1962 ADOPTED AT THE NINETEENTH SESSION AND SUBSEQUENT DECISIONS OF THE COUNCIL THE COMMITTEE ON BALANCE-OF-PAYMENTS RESTRICTIONS WILL MEET FROM 24 SEPTEMBER TO CARRY OUT CONSULTATIONS UNDER THE RELEVANT PROVISIONS OF ARTICLES XII AND XVIII:B WITH CHILE, DENMARK, FINLAND, INDIA, JAPAN, NEW ZEALAND, SOUTH AFRICA AND URUGUAY. IN ADDITION IT HAS BEEN SUGGESTED THAT THE RECENT MEASURES TAKEN BY CEYLON FOR BALANCE-OF-PAYMENTS REASONS SHOULD BE DEALT WITH BY THE COMMITTEE. THE MEETING OF THE COMMITTEE WILL COMMENCE AT 3 P.M. ON MONDAY 24 SEPTEMBER AT THE PALAIS DES NATIONS, GENEVA.
