SUBJECT: MEETING OF COUNCIL ON 22 OCTOBER 1962

THE NEXT MEETING OF THE COUNCIL OF REPRESENTATIVES WILL BE HELD IN THE PALAIS DES NATIONS AT 3 P.M. ON MONDAY, 22 OCTOBER.

THE FOLLOWING ARE THE ITEMS WHICH REQUIRE CONSIDERATION BY COUNCIL:

1. BUDGET, FINANCE AND ADMINISTRATION

THE COMMITTEE ON BUDGET, FINANCE AND ADMINISTRATION HAS SUBMITTED A REPORT IN DOCUMENT L/1842. THE COUNCIL'S RECOMMENDATIONS WILL BE SUBMITTED TO THE TWENTIETH SESSION.

2. RESIDUAL IMPORT RESTRICTIONS

THE COUNCIL WAS INSTRUCTED BY THE CONTRACTING PARTIES TO REVIEW THE PROCEDURES FOR DEALING WITH RESIDUAL RESTRICTIONS (9S/19) AND TO REPORT TO THE TWENTIETH SESSION. THE REPORT BY THE PANEL OF EXPERTS, WHICH EXAMINED THE ADEQUACY OF NOTIFICATIONS OF RESIDUAL RESTRICTIONS, HAS BEEN DISTRIBUTED IN DOCUMENTS L/1774 AND ADD.1 AND THE LIST OF RESTRICTIONS IN L/1769.

AUSTRALIAN SCHEDULE

A REQUEST BY THE GOVERNMENT OF AUSTRALIA FOR AUTHORITY UNDER PARAGRAPH 4 OF ARTICLE XXVIII TO ENTER INTO RENEGOTIATION FOR THE MODIFICATION OR WITHDRAWAL OF CERTAIN BOUND ITEMS IS BEING DISTRIBUTED IN GATT/AIR/303 (SECRET).

REPRESENTATIVES ARE REQUESTED TO ADVISE ME OF THE NAMES OF ANY ADVISERS WHO WILL ACCOMPANY THEM AT THIS MEETING. CONTRACTING PARTIES AND ASSOCIATED GOVERNMENTS, NOT MEMBERS OF THE COUNCIL, AND INTERGOVERNMENTAL ORGANIZATIONS DESIRING TO BE REPRESENTED BY OBSERVERS SHOULD INFORM ME OF THE NAMES OF THEIR REPRESENTATIVES NOT LATER THAN 19 OCTOBER.
