SUBJECT: MEETING OF COUNCIL 19-23 FEBRUARY 1963

THE COUNCIL AGREED ON 16 JANUARY THAT ITS NEXT MEETING SHOULD BE HELD FROM 18-23 FEBRUARY. IT HAS BEEN POINTED OUT TO ME, HOWEVER, BY A NUMBER OF REPRESENTATIVES THAT IT WOULD BE MORE CONVENIENT IF THE COUNCIL COMMENCED ITS MEETING ON 19 FEBRUARY. ON THE PRESUMPTION THAT REPRESENTATIVES WILL AGREE TO MEET THE WISHES OF THE COUNTRIES CONCERNED, THE NEXT MEETING WILL HE HELD IN THE INTERNATIONAL LABOUR OFFICE, GENEVA ON TUESDAY, 19 FEBRUARY.

THE PRINCIPAL MATTER FOR CONSIDERATION BY THE COUNCIL WILL BE THE ARRANGEMENTS TO BE MADE FOR THE MEETING OF MINUSTERS PURSUANT TO THE INSTRUCTIONS GIVEN BY THE CONTRACTING PARTIES DORING THE TWENTIETH SESSION WHICH WERE AS FOLLOWS:

- "(I) A MINISTERIAL MEETING SHOULD BE HELD IN THE EARLY PART OF 1963 TO CONSIDER A PROGRAMME FOR EFFECTIVE LIBERALIZATION AND EXPANSION OF TRADE IN BOTH PRIMARY AND SECONDARY PRODUCTS. IN THIS CONNEXION, FULL WEIGHT SHOULD BE ATTACHED TO THE IMPORTANCE AND URGENCY OF NEGOTIATING SOLUTIONS TO THE PROBLEMS OF TRADE IN PRIMARY PRODUCTS AND TO THE ADDITIONAL TRADE PROBLEMS OF THE LESS-DEVELOPED COUNTRIES.
 - (II) A PRECISE DATE FOR THE MEETING SHOULD BE DETERMINED BY THE COUNCIL.
 - (III) THE COUNCIL SHOULD BE CONVENED FOR THIS PURPOSE BY THE EXECUTIVE SECRETARY AT THE EARLIEST POSSIBLE DATE THAT HE FEELS THAT THE NECESSARY ELEMENTS EXIST FOR ARRIVING AT A DECISION.
 - (IV) IN THIS CONNEXION, DUE WEIGHT SHOULD BE ATTACHED TO THE FACT THAT IN OBJER TO ENABLE THE UNITED STATES TO PLAY A FULL PART IN A FURTHER SUBSTANTIAL AND EARLY MOVEMENT FOR THE REDUCTION OF TARIFFS AND OTHER BARRIERS TO TRADE, IT IS DESIRABLE THAT THE NECESSARY DECISION TO INITIATE SUCH A MOVEMENT BE TAKEN EARLY IN 1963.
 - (V) THE COUNCIL SHOULD AT THE SAME TIME, IN THE LIGHT OF THE DISCUSSIONS AT THE TWENTIETH SESSION, PROPOSE AN AGENDA FOR THE MEETING OF MINISTERS AND MAKE ADEQUATE PREPARATIONS FOR THE MEETING." (SR.20/10, PAGE 156.)

CONTRACTING PARTIES AND ASSOCIATED GOVERNMENTS, NOT MEMBERS OF THE COUNCIL, AND INTERGOVERNMENTAL ORGANIZATIONS DESIRING TO BE REPRESENTED BY OBSERVERS SHOULD INFORM ME OF THE NAMES OF THEIR REPRESENTATIVES NOT LATER THAN 15 FEBRUARY.
