SUBJECT: MEETING OF THE TNC SUB-COMMITTEE ON NON-TARIFF BARRIERS

1. IT WAS PROPOSED IN GATT/AIR/350 THAT THE TNC SUB-COMMITTEE ON NON-TARIFF BARRIERS AND OTHER SPECIAL PROBLEMS SHOULD MEET FROM 4-15 NOVEMBER. AT ITS MEETING ON 29-30 OCTOBER, THE COUNCIL OF REPRESENTATIVES DECIDED THAT THE MEETING SHOULD BE HELD BETWEEN 11 AND 15 NOVEMBER. THE MEETING WILL BEGIN AT 10 A.M. ON TUESDAY 12 NOVEMBER AT THE PALAIS DES NATIONS, GENEVA.
2. AN INDICATION OF THE PRINCIPAL SUBJECTS FOR CONSIDERATION IS GIVEN IN PARAGRAPHS 8 AND 9 OF GATT/AIR/343. PAPERS RELEVANT TO THE WORK OF THE SUB-COMMITTEE, INCLUDING SUBMISSIONS RECEIVED FROM GOVERNMENTS, ARE DISTRIBUTED IN DOCUMENTS BEARING THE SYMBOL TN.64/NTB.
3. MEMBERS OF THE SUB-COMMITTEE ARE REQUESTED TO ADVISE ME AS SOON AS POSSIBLE OF THE NAMES OF THEIR REPRESENTATIVES.

3. LES MEMBRES DU SOUS-COMITE SONT PRIES DE ME COMMUNIQUER LE PLUS TOT POSSIBLE LES NOMS DE LEURS REPRESENTANTS.
