SUBJECT: WORKING PARTY ON RELATIONS WITH POLAND

1. THE COUNCIL OF REPRESENTATIVES AT ITS MEETING ON 6 JULY DECIDED THAT THE WORKING PARTY ON RELATIONS WITH POLAND SHOULD MEET DURING THE WEEK BEGINNING 5 OCTOBER. THE MEETING WILL BE HELD IN THE PALAIS DES NATIONS BEGINNING AT 3 P.M. ON 5 OCTOBER.
2. THE WORKING PARTY IS TO CONDUCT THE THIRD ANNUAL REVIEW UNDER PARAGRAPHS A:4 AND B:3 OF THE DECLARATION OF 9 NOVEMBER 1959 ON RELATIONS BETWEEN CONTRACTING PARTIES AND POLAND AND TO SUBMIT A REPORT TO THE CONTRACTING PARTIES. THE MEMBERSHIP OF THE WORKING PARTY IS AS FOLLOWS:

OTHER COUNTRIES WHICH ARE PARTIES TO THE DECLARATION WISHING TO BECOME MEMBERS OF THE WORKING PARTY SHOULD INFORM THE SECRETARIAT AS SOON AS POSSIBLE.

3. FOR THE SUBJECT MATTER TO BE COVERED BY THE THIRD REVIEW REFERENCE MAY BE MADE TO BISD, 12TH SUPPLEMENT, PAGE 62. GOVERNMENTS ARE REQUESTED TO SUPPLY THE SECRETARIAT WITH ALL INFORMATION THEY CONSIDER TO BE RELEVANT FOR THE REVIEW. IN CASES WHERE INFORMATION WAS SUPPLIED FOR THE SECOND REVIEW (SEE L/2058, ANNEX I) IT WILL BE SUFFICIENT FOR THE GOVERNMENT CONCERNED TO SUPPLY A SUPPLEMENTARY STATEMENT BRINGING THIS INFORMATION UP TO DATE.

4. MEMBERS OF THE WORKING PARTY AND THE GOVERNMENT OF POLAND, AS WELL AS ANY CONTRACTING PARTIES AND ASSOCIATED GOVERNMENTS WISHING TO BE REPRESENTED BY OBSERVERS, ARE REQUESTED TO INFORM ME AS SOON AS POSSIBLE OF THE NAMES OF THEIR REPRESENTATIVES.
