9. PROVISIONAL ACCESSION

THE DECLARATIONS PROVIDING FOR THE PROVISIONAL ACCESSION OF ARGENTINA, SWITZERLAND AND UNITED ARAB REPUBLIC EXPIRE AT THE END OF 1964.

COUNCIL MEMBERS ARE REQUESTED TO ADVISE ME BY 26 OCTOBER OF THE COMPOSITION OF THEIR DELEGATIONS. CONTRACTING PARTIES AND ASSOCIATED GOVERNMENTS, NOT MEMBERS OF THE COUNCIL, AND INTERGOVERNMENTAL ORGANIZATIONS DESIRING TO BE REPRESENTED BY OBSERVERS, SHOULD INFORM ME OF THE NAMES OF THEIR REPRESENTATIVES.
