SUBJECT: ASSOCIATION BETWEEN THE EUROPEAN ECONOMIC COMMUNITY AND CERTAIN NON-EUROPEAN COUNTRIES AND TERRITORIES

IN DOCUMENT L/2342 THERE HAS BEEN CIRCULATED THE TEXT OF A DECISION OF THE COUNCIL OF THE EUROPEAN ECONOMIC COMMUNITY WHICH DEFINES FOR A FURTHER PERIOD OF FIVE YEARS THE PROVISIONS FOR THE ASSOCIATION BETWEEN THE EUROPEAN ECONOMIC COMMUNITY AND CERTAIN NON-EUROPEAN COUNTRIES AND TERRITORIES MAINTAINING SPECIAL RELATIONS WITH FRANCE AND THE NETHERLANDS. THIS MATTER HAS BEEN INCLUDED AS AN ITEM IN THE PROVISIONAL AGENDA FOR THE TWENTY-SECOND SESSION OF THE CONTRACTING PARTIES AND THE COUNCIL AT ITS MEETING ON 28 JANUARY DECIDED TO RECOMMEND THAT THE DECISION SHOULD BE REFERRED TO THE WORKING PARTY WHICH IS TO MEET DURING THE SESSION TO EXAMINE THE CONVENTION OF ASSOCIATION OF THE AFRICAN AND MALAGASY STATES.

IT WOULD FACILITATE THE EXAMINATION OF THIS MATTER AT THE SESSION IF CONTRACTING PARTIES WISHING TO PUT FORWARD QUESTIONS CONCERNING THE PROVISIONS AND IMPLEMENTATION OF THE DECISION WOULD SUBMIT THESE TO THE SECRETARIAT BEFORE THE OPENING OF THE SESSION.

LE DOCUMENT L/2342 REPRODUIT LE TEXTE D'UNE DECISION DU CONSEIL DE LA CEE QUI DEFINIT, POUR UNE NOUVELLE PERIODE DE CINQ ANNEES, LES MODALITES DE L'ASSOCIATION ENTRE LA CEE ET CERTAINS PAYS ET TERRITOIRES NON EUROPEENS, ENTRETENANT AVEC LA FRANCE ET LES PAYS-BAS DES RELATIONS PARTICULIERES. CETTE QUESTION A ETE INSCRITE A L'ORDRE DU JOUR PROVISOIRE DE LA VINGT-DEUXIEME SESSION DES PARTIES CONTRACTANTES. ET LE CONSEIL A DECIDE, A SA REUNION DU 28 JANVIER, DE RECOMMANDER QUE LA DECISION SOIT RENVOYEE, POUR EXAMEN, AU GROUPE DE TRAVAIL QUI DOIT SE REUNIR PENDANT LA SESSION AFIN D'ETUDIER LA CONVENTION D'ASSOCIATION DES ETATS AFRICAINS ET MALGACHE AVEC LA CEE.

AFIN DE FACILITER L'EXAMEN DE CE POINT AU COURS DE LA SESSION, LES PARTIES CONTRACTANTES QUI DESIRERAIENT POSER DES QUESTIONS SUR LES DISPOSITIONS DE LA DECISION ET SUR SA MISE EN OEUVRE SONT PRIEES DE COMMUNIQUER CES QUESTIONS AU SECRETARIAT AVANT L'OUVERTURE DE LA SESSION.
