SUBJECT: WORKING PARTY ON RELATIONS WITH POLAND

1. AT ITS MEETING ON 12 JULY 1965, THE COUNCIL OF REPRESENTATIVES APPOINTED A WORKING PARTY TO CONDUCT THE FOURTH ANNUAL REVIEW UNDER PARAGRAPHS A:4 AND B:5 OF THE DECLARATION OF 9 NOVEMBER 1959 ON RELATIONS BETWEEN CONTRACTING PARTIES AND POLAND AND TO SUBMIT A REPORT TO THE CONTRACTING PARTIES.

2. THE WORKING PARTY WILL MEET IN THE PALAIS DES NATIONS BEGINNING AT 10 A.M. ON 9 MARCH. THE MEMBERSHIP OF THE WORKING PARTY IS AS FOLLOWS:

OTHER COUNTRIES WHICH ARE PARTIES TO THE DECLARATION WISHING TO BECOME MEMBERS OF THE WORKING PARTY SHOULD INFORM THE SECRETARIAT AS SOON AS POSSIBLE.

3. FOR THE SUBJECT MATTER TO BE COVERED BY THE FOURTH REVIEW REFERENCE MAY BE MADE TO BISD, THIRTEENTH SUPPLEMENT, PAGE 33. GOVERNMENTS ARE REQUESTED TO SUPPLY THE SECRETARIAT WITH ALL INFORMATION THEY CONSIDER TO BE RELEVANT FOR THE REVIEW AS SOON AS POSSIBLE AND IN ANY CASE BY 1 MARCH. IN CASES WHERE INFORMATION WAS SUPPLIED FOR THE THIRD REVIEW (D/2276 ANNEX 3) IT WILL BE SUFFICIENT FOR THE GOVERNMENT CONCERNED TO SUPPLY A SUPPLEMENTARY STATEMENT BRINGING THIS INFORMATION UP TO DATE.

4. MEMBERS OF THE WORKING PARTY AND THE GOVERNMENT OF POLAND, AS WELL AS ANY CONTRACTING PARTY AND ASSOCIATED GOVERNMENT WISHING TO BE REPRESENTED BY OBSERVERS, ARE REQUESTED TO INFORM ME AS SOON AS POSSIBLE OF THE NAMES OF THEIR REPRESENTATIVES.
